# 6. DETERMINATION OF CONTINUED ENTITLEMENT TO RETAIN A HACKNEY CARRIAGE AND PRIVATE HIRE VEHICLE DRIVERS LICENCE

The Director of Neighbourhood and Environmental Services submitted a report that required Members to determine an application for the Determination of Continued Entitlement to Retain a Hackney Carriage and Private Hire Vehicle Driver's Licence.

The driver was present, along with his Interpreter. The Licensing Team Manager and Legal Adviser to the Sub-Committee were also present.

The Licensing Team Manager presented the report and outlined details of the driver, including the relevant City Council Guidelines.

The driver, through his interpreter, was invited to set out the reasons why the driver's entitlement to a Hackney Carriage and Private Hire Vehicle Driver's Licence should continue. The driver answered questions from Members and

#### Officers.

All parties present were given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present.

In reaching their decision, Members felt they should deliberate in private on the basis that this was in the public interest, and as such outweighed the public interest of their deliberation taking place with the parties represented present.

The Chair announced that the decision and reasons made during private deliberation would be publicly announced in writing within five working days.

The Chair informed the meeting the Legal Adviser to the Sub-Committee would be called back to give advice on the wording of the decision.

The Chair then asked all but Members of the Sub-Committee and Democratic Support Officer to leave the meeting. The Sub-Committee then deliberated in private to consider their decision.

The Sub-Committee recalled the Legal Adviser to the Sub-Committee to give advice on the wording of the decision.

# **RESOLVED:**

That the Hackney Carriage and Private Hire Vehicle Driver's Licence be REVOKED as Members were not satisfied that the driver remained a fit and proper person to hold a licence

Members of the Sub-Committee had been asked to determine whether the driver should be entitled to retain his Hackney Carriage and Private Hire Vehicle Drivers Licence. Members had considered this in accordance with Section 61 of the Local Government (Miscellaneous Provisions) Act 1976.

In reaching their decision, the Sub-Committee Members had carefully considered the Committee report presented by the Licensing Manager, all representations and the legal advice provided.

The Sub-Committee Member's considered the licensing objectives to be of paramount concern together with the protection and safety of the travelling public. They had considered the application on its own merits and all other matters including unemployment were secondary to the public safety factor.

Members had not taken anything presented to them at face value and confirmed that they had scrutinised all information put before them by all parties to the proceedings.

The driver would be provided with reasons for the decision in writing within 5 working days.

All parties would be advised of the right to appeal the decision.

#### 7. PERSONAL LICENCE REVIEW APPLICATION

The Director of Neighbourhood and Environmental Services submitted a report that required Members to determine the review of a personal licence issued by this authority.

The Licensing Team Manager presenting the report and Legal Adviser to the Sub-Committee were present.



# APPLICATION FOR STREET TRADING CONSENT MR NAVEEN MAMIDI HOUSE OF HYDERABAD, OPPOSITE 36 VICTORIA PARK ROAD, LEICESTER

Report of the Director of Neighbourhood and Environmental Services

# 1. Location



# 2. Purpose of the Report

To determine an application for the grant of a street trading consent under Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982, House of Hyderabad. The applicant is Mr Naveen Mamidi.

# 3. Options for the Sub-Committee

The Sub-Committee may determine the application in one of the following ways:-

- (a) Grant the application, or
- (b) Refuse the application.

A licensing authority may attach such conditions as they consider reasonably necessary when granting or renewing a street trading consent. This may include conditions to prevent obstruction of the street or danger to persons using it, or nuisance or annoyance (whether to persons using the street or otherwise). The authority may at any time vary the conditions of a street trading consent.

The authority may include in a street trading consent permission for its holder to trade in a consent street

- a) from a stationary van, cart, barrow or other vehicle; or
- b) from a portable stall.

If the authority includes such a permission, it may make the consent subject to conditions

- a) as to where the holder of the street trading consent may trade by virtue of the permission, and
- b) as to the times between which or periods for which he may so trade.

A street trading consent may be granted for any period not exceeding 12 months but may be revoked at any time.

There is no right of appeal against a determination of the Licensing Authority in this instance, but as a matter of good practice Members should give reasons for their decision at the time it is announced.

#### 4. Recommendation

It is recommended that the application be refused in accordance with the City Council's street trading policy.

# 5. Report

Mr Mamidi has applied for the grant of a street trading consent for House of Hyderabad, opposite 36 Victoria Park Road, Leicester, under schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982. A copy of the application is attached at Appendix A.

Mr Mamidi would like to sell South Indian breakfast foods including dosa, biryani's, roti's and curries, Monday to Sunday 8.00am to 11.00pm.

# Street trading policy

The policy says that there will be a general presumption in favour of granting consents for street trading by ice cream vans and by mobile operators who remain stationary at a particular location only long enough to serve customers at that location, provided that they conform to any code of practice issued by the City Council.

The policy provides for certain exceptions, including:

a) The immediate vicinity of Leicester City Football Club and Leicester Tigers, for the purpose of the sale of favours and materials associated with the football clubs that are organised and controlled by those clubs. 16

- b) Operators selling food who wish to trade on industrial estates, where no other adequate provision is provided.
- c) Limited period consents in respect of particular types of operations in conjunction with specific events in the City.

None of these exceptions are relevant to this application.

Other applications for consents will be considered and each case will decided on its own merits. The following matters will be taken into account:

- Public nuisance
- Crime and disorder
- Road safety
- Health and safety at schools and for their pupils
- Likely demand for goods being sold
- Availability of goods being sold in other fixed premises in the vicinity
- Objections received from nearby residents, businesses and statutory agencies

# Representations

Details of the application have been passed to the Police, Highways, Noise Control, and the Food Team. A letter was sent to the Head Teacher at St Crispin's School and a notice has been placed at the location concerned for two weeks inviting anyone affected by the proposal to submit representations to the Licensing section.

No representations have been received from the Police, Highways, Noise Control and the Food Team in relation to this application. However, twenty-three representations have been received from members of the public and a ward councillor.

The representees are concerned that if this application if granted, it will cause more traffic and parking issues on an already very congested road. It will also increase odour, litter, noise and anti-social behaviour. Copies of the representations are attached at Appendix B1-23.

# 6. Legal Implications (Including Human Rights Act)

A licensing decision is a determination of civil rights to which Article 6 Right to a fair trial principles apply. Article 1 of the First Protocol gives the right of peaceful enjoyment of possessions, which would include a street trading consent.

Schedule 4 paragraph 7 of the Local Government (Miscellaneous Provisions) Act 1982 details the procedure to be followed for the grant and renewal of street trading consents. The council and the holder of a street trading consent must comply with the requirements of this paragraph.

Schedule 4 paragraph 8 of the Local Government (Miscellaneous Provisions) Act 1982 enables the holder of a street trading consent to employ any other person to assist in their trading without a further consent being required.

Where a consent is surrendered or revoked, the council shall remit or refund as they consider appropriate the whole or a part of any fee paid for grant or renewal of the consent as per Schedule 4 paragraph 9(5) of the Local Government (Miscellaneous Provisions) Act 1982.

A person who engages in street trading without a street trading consent, or who makes a false statement in connection with an application for a consent may be subject to prosecution, and upon conviction may be liable for a fine of up to £1,000, pursuant to Schedule 4 paragraph 10 of the Local Government (Miscellaneous Provisions) Act 1982

I am writing to object to this application for a fixed trailer for sale of food/drink opposite 36 Victoria Park Road. Reasons are as follows

- There is a school close by on St Mary's Road (St Crispin's). This school caters for all ages and hours are 8.30am - 5.10pm.
- There is no crossing point near to the trailer. This would mean anyone coming up St Mary's Road in particular (including school students and parents) would be crossing to it near a difficult junction. It would also mean anyone crossing from the park side at this point may be masked by the trailer.
- There may be further traffic hazard as the trailer would be wider than a standard parked vehicle and could cause congestion at this point close to junction.
- There would be no hard standing next to the van at this point. There is grass verge and then a cycle lane on which customers would have to queue. This risks conflict between customers and cyclists, and also cyclists and pedestrians walking by if cyclists swerve onto footway to avoid the customers.
- There is no exceptional reason to have a street food venue here. There is a wide range of culturally varied food outlets on Queens Road, London Road and Evington Road. If the trader wants to offer something different they should open in one of these locations rather than spreading activity such as litter, noise etc into a residential area. If planned to attract park users it's quite a long way from the toilets, which might mean customers use 'alternatives'. A better option might be to have a temporary mobile unit at park pavilion while waiting for that café to be refurbished and let.
- The photo taken from Google maps shows the lovely open views across Vicky Park (including of the war memorial). The Grade 2 listed park and Stoneygate Conservation Area adjoin at this point. A permanent structure would not be allowed in such a location, but a trailer like this is inevitably going to be there constantly (local examples further down Victoria Park Road and near Opal Court). Please don't allow these views to be blocked with an unattractive trailer.
- The trailer is proposed to be on one of few unrestricted parking spaces on Victoria Park Road. These are very valuable and rarely empty during daytime. Presumably customers using cars are expected to use the short-stay spaces alongside, but spaces here are also limited and important for users of the park or visitors to the homes opposite. There are double-yellow lines opposite, so risk of passer-by customers double-parking, pulling up on footway opposite, or blocking the driveway to the flats.
- The justification given for this application appears to be cut and paste from an American source?.
  There has been no 'consultation' with nearby neighbours and community, no 'crosswalk', road humps etc provided. There is little that is specific to the location as you'd expect. So I don't trust any of it.

- 1. Safety. There is no safe road crossing place nearby. A large food truck will obscure vision and make crossing nearby dangerous. St Crispin's School is just on the other side of Victoria Park Road and a food truck will encourage pupils to cross.
- 2. The litter bins nearby are already totally inadequate. It is reasonable to assume that a food truck will increase the volume by an order of magnitude. There are a number of foxes living in the vicinity and they scavenge and will spread any discarded food wrappers and containers producing a serious health risk.
- 3. There are no nearby toilets. The closest are on the other side of Victoria Park. The increased footfall and consumption of food and drink will most likely result in people relieving themselves in St. Marys Park on the other side of Victoria Park Road.
- 4. There are already instances of people using the area around St. Mary's Park at night for illicit purposes such as drug dealing. A food truck nearby will obviously act as a magnet for more of the same activity.

- 1. The business case on how to address impacts of public nuisance, crime and disorder, road safety and so on, and not relevant, are incorrect and may have been copied from another application. (Re: licence application, page 1)
- 2. This application is for a fixed installation which would be a public nuisance and inhibit an open view across the park.
- 3. The attached photograph's of the trailer indicate it is wider than other parked cars on Victoria Park Road thus create a traffic hazard and be a road safety issue.
- 4. This application is within the Stoneygate Conservation Area, which is unacceptable.
- 5. There are no safe crossing points at this part of Victoria Park Road, which would bring road safety risks particularly for schoolchildren attempting to cross the road.
- 6. The application is in close proximity to St Crispin's School on St Mary's Road. Fast food places should not open close to schools which would help tackle childhood obesity.

This is an objection to the application for a street trading licence opposite 36 Victoria Park Road. My grounds for objecting are:

Detrimental impact on the Stoneygate Conservation Area. The frontages along this section of Victoria Park Road have been protected to preserve local heritage and retain an attractice backdrop when seen from the park. A permanently parked food trailer will damage this view ans be detrimental to the conservation area.

Traffic hazard and loss of parking - the trailer will project into the main carriageway as it is significantly wider than a car, which would usually be parked there. The section of Victoria Park Road adjacent to the proposed trailer site is regulated short-term parking primarily to allow park users to stop and enjoy the park. There is high demand for these spaces, as there is for the unrestricted spaces along this section of the road, and trading from this site will make normal parking and recreational activity more difficult. It will have a further impact on parking in St Mary's Road.

Risk to pedestrians - there are no nearby pedestrian crossings on Victoria Park Road. The road is always busy during the day, and in the evenings traffic speeds tend to increase. Street trading at this point will attract more foot traffic to the area with consequent increased risk.

Noise, littering and disturbance - all will increase if street trading is allowed at this point. There is an existing problem with litter from the park, overflowing litter bins on the park, and discarded food packaging from people stopping to eat takeaway food and throwing their litter into the road. Street trading will only make these worse.

No toilet provision - there are no nearby public toilets. If street trading is allowed it will again increase an existing problem of people using the park and front gardens as toilet facilities.

Impact on wider area - residents of St Mary's Road already experience late evening difficulties with groups meeting in cars and creating noise and litter on the road and in the adjacent Triangle Park. If street trading is allowed just across the road this will become a recognised place for late evening eating and socialising to the detriment of nearby residents and to the condition of the Triangle Park. There is also a school In St Mary's Road on which nearby street trading will have a further impact.

I am aware that there is widespread concern about this licence application, and additional grounds for objection will certainly be given. Rather than add to the list I am making I will conclude by saying that it is difficult to think of a more inappropriate site for street trading in this area.

We are contacting you on behalf of ourselves and many others in the community who strongly object the Street Trading Consent application 154108. We personally are a family who live at 1 Firstly we only found out about this proposed trading due to the Friends of Clarendon Park meeting on Friday, so has left very little time for locals to get their objections in by Tuesday this week, none of us locals living close has any idea this application had been submitted and the owners made on attempt to communicate or justify their application to the locals who will have to deal with the damage caused by it on a daily basis. The first issue is the problems it will cause to the road, litter is already a major problem in our area with many cars parking to eat their fast food then throwing it out their window, the last thing we need is fast food more accessible so more litter can be thrown on our streets, the bins on the road and park are already full as is, without another food outlet and the rubbish it brings. The only reason the litter is cleared currently is that locals volunteer in their own time pick the litter streets. We also already have large problems with there never being parking on our road, it is bad enough with the school as daily we have parents blocking access to our drive, with this new food trucks ridiculous hours of operations we will have a constant flow of more cars parking on our road through the day and night, this is without the obstructions deliveries will cause as well. It is already difficult for people visiting locals to park in the area as well the last thing we need is the loss of already scarce unrestricted parking places. St Mary's Road is also a conservation area with houses such as our own that are of historical importance, the last thing we need is an eyesore of a modern food truck ruining the appearance of the local area and obstructing the view of the park. There is also an issue of the danger of the location being as there is no crossing on the road close to the proposed position, Victoria Park Road continues to get busier and busier since the new road arrangement, it is too risky having people running across the road just to get fast food and it would be irresponsible of the council to let this go ahead. The Trailer is also wider than other parked vehicles, causing yet another obstruction to the already busy flow of traffic. There are also many local established businesses in walking distance with other Indian restaurants such as friends on queens road and another Indian food truck further down Victoria Park road. This food truck opening will only cause more competition for these business and take business away from Queens Road which has already been struggling since the pandemic, also why do we need another food truck when there is already one in a more convenient place near QE and the University which cater to students and others already. We have also already made the police aware multiple times of the antisocial behaviour that happens around our area, our daughter is scared to walk outside our house at night, due to antisocial behaviour such as drug deals that often happen outside our house, the food truck will be yet another attraction and convenience encouraging them to our area which is a peaceful family neighbourhood with the school. - The application makes reference to parking areas for customers. There is no such thing
  where the trailer is proposed as this is for park users/residents/visitors not a permanent
  trailer which would take up more than two normal vehicles parking spaces
- 2. Parking is already at a premium in CP and especially on Victoria Park Rd?/Queens Rd and the adjacent streets with the residents parking scheme
- 3. The trailer appears to be wider than a normal vehicle and would therefore restrict the passing of vehicles
- 4. The applicants information provided would appear to be copied and pasted from somewhere as it talks about traffic calming measures such as speed bumps or roundabouts, defensive driving what does any of this have to do with the application. And they mention they have developed partnerships with local schools to support health and well being etc. I assume the likes of St Crispin's, St Johns, QE could substantiate these claims?
- 5. The trailer would need a generator running for the duration of the hours of operation from 8.00am until 11.00pm with the associated pollution both from fumes and noise. If this was 7 days a week this would be 15 hrs per day 7 days a week meaning it would be running for 105hrs per week

Furthermore, the immediate area of the proposed venture is currently blighted by lots of litter, dropped by people who drive into the area to consume food purchased elsewhere (along with consumption of other substances). The provision of a mobile catering unit in this location will worsen the existing problem.

The area is residential and the proposed unit will increase traffic which is counter to the Council's aims to reduce traffic and local car journeys.

I would anticipate that the menu offering will be biased towards high fat and salt and fried goods which I am not opposed to in moderation, but if this is the case, the city has plenty of food outlets offering this at all hours and, therefore, in terms of the City Council's aims around health and diet, another business of this sort is not needed.

I hope you will take these points into account when considering the application.

I write to notify you of our objection to the application for a Street Trading Consent for the positioning of a food van opposite 36 Victoria Park Road, Leicester by Mr Naveen Mamidi trading as House of Hyderabad.

The proposed location of this van, selling "South Indian breakfast foods including Dosa, Biryani, Roti's & Curries" is entirely inappropriate for the following reasons:

- The area surrounding the application site is a residential area;
- The location is within the vicinity of a school

The Leicester City Council Street Trading Policy (2009) states:

- "3. There will be a general presumption against street trading, particularly in the vicinity of schools. For the purposes of this policy, a location is 'in the vicinity' of a school if it is situated such that pupils may be encouraged to walk to it during a break from school, or immediately before or after school."
- "7. Street trading consents may be granted to operators selling food who wish to trade on industrial estates, where no other adequate fixed provision is provided."
- "8. Limited period consents may be granted in respect of particular types of operations in conjunction with specific events in the City. Applicants for limited period consents will need to liaise with the Council's Festivals Unit before applying for street trading consent, as the only limited period consents that will be granted are those that are organised in conjunction with a significant event in the city."
- "9. Other applications for consents will be considered and each case will decided on its own merits. The following matters will be taken into account:
- Public nuisance
- Crime and disorder
- Road safety
- Health and safety at schools and for their pupils
- · Likely demand for goods being sold
- · Availability of goods being sold in other fixed premises in the vicinity
- Objections received from nearby residents, businesses and statutory agencies"

Taking these in order:

The proposed location is within 100m, or a one minute walk of a school on St Marys Road.

The area surrounding the proposed location is residential with no business premises within a 200m walking distance.

The application is for a 12 month consent which leads me to believe that the application is not in conjunction with any specific events in the city.

The application is for a consent to trade between 8am to 11pm. The proposed location is currently heavily used for parking during the day, and often at night by visitors to De Montfort Hall etc. At weekends, problems are experienced in the area with people parking on the pavement and double

yellow lines on the opposite side of Victoria Park Road whilst dropping off, picking up and waiting for participants in football practice and matches on Victoria Park. The area frequently experiences nuisance noise from individuals and groups parking up by the park listening to loud music, smoking and running car engines at night. Often there is food related litter and debris found in the gutter and on the verge in this area. The location of a food van will only exacerbate this by reducing the space available for cars to park, encouraging more illegal parking on double yellow lines by customers unable to park in the designated parking areas, drawing more anti-social behaviour such as noise and litter and vermin through inevitable food debris.

The location is within close proximity to a range of fixed food retail outlets on Queens Road, London Road and Evington Road, some of which will sell similar food offerings. The proposed location is also around 600m away from a similar food retail van on Victoria Park Road, opposite Hartopp Road.

Looking at the details provided by the applicant, we struggle to understand how some of the answers given are possible.

The applicant claims that they have installed soundproofing to minimize noise and prevent disturbance to neighbours, that they have parking areas for customers and have provided clear signage to help direct traffic to prevent congestion, that they have implemented traffic calming measures such as speed bumps or roundabouts to help reduce the risk of accidents, they have provided safe and convenient access for pedestrians and cyclists, such as by installing crosswalks, bike lanes, or sidewalks. They claim to have provided resources and support to help schools and families educate students about road safety, have taken steps to ensure are safe and healthy for students by offering nutritious food options or promoting physical activity... we could go on.

The application states that "Our business proposal has been developed in consultation with local residents, community groups, and other stakeholders. We have sought feedback and input from these groups throughout the planning process, and we believe that our proposal has been designed to meet their needs and preferences." We have been resident at our property for over twelve months, many of our neighbours have been here far longer. There has been no consultation with anyone in the block immediately opposite the application site. Indeed, the first we knew about this proposal was just before the deadline for representations to be made.

In summary, we object to the application for a Street Trading Consent for the above business at the above location.

**Re:** Street Trading Licence application 154108 by House of Hyderabad for a fixed site selling food and soft drinks for an initial 12 month period beginning on 30/06/2023 from 8am to 11pm daily, opposite 36 Victoria Park Road.

Please accept this **objection** on behalf of Friends of Clarendon Park (FCP) on the following grounds:

#### General

The explanations of how the business would impact on public nuisance, crime and disorder, road safety, health and safety at schools and for their pupils are at best generic and at worst irrelevant. These explanations do not relate directly to the proposal and use American terms such as crosswalk and sidewalk, suggesting that the text has just been cut-and-pasted from elsewhere.

#### **Parking**

The parking on this section of Victoria Park Road is either unrestricted or restricted to 'Mon-Sat 09:30am-4pm, 1 hour, No return within 1 hour', so there can be no 'designated parking areas' as claimed in the application. The unrestricted parking is usually occupied all day long by commuters and the 1-hour parking is intended for park users. Allowing a food trailer to be permanently parked in this location would remove two unrestricted parking spaces for the trailer in addition to any spaces occupied by customers, when such spaces are already scarce in this area and therefore in very high demand.

#### Consultation

The application claims to have consulted with local authorities, community groups, residents and other community members on various matters when no such consultation has taken place, certainly with community groups, residents or other community members.

#### **Partnerships**

The application also claims to have developed partnerships with local law enforcement agencies, public transit agencies, local schools, community organisations to address various matters when no such partnerships have been developed, certainly with local schools or community groups.

## Access

The proposed location is equidistant from the two crossings of Victoria Park Road, one near the junction with London Road and the other near the junction with Queens Road, meaning that there are no safe crossing points nearby.

#### **Hazards**

The trailer proposed would be significantly wider and higher than the cars usually parked in this area, projecting further into the carriageway and creating a hazard for other road users as well as making it more difficult for pedestrians to cross Victoria Park Road at this point while being able to see approaching traffic and be seen by that traffic.

## **Schools**

The <u>LCC Street Trading Policy and Code of Practice</u>, Mar 2020 states that:

There will be a general presumption against street trading, particularly in the vicinity of schools. For the purposes of this policy, a location is 'in the vicinity' of a school if it is situated such that pupils may be encouraged to

walk to it during a break from school, or immediately before or after school.

The proposed location is less than 100m from St Crispin's Grammar School at 6 St Mary's Road, Leicester LE2 1XA, which is clearly within easy walking distance for even the youngest pupils.

#### **Toilets**

The proposed trailer would provide no toilet facilities and the nearest public toilets are 450m away across Victoria Park. This is likely to result in Victoria Park, the front gardens of the properties along Victoria Park Road and St Mary's Triangle being used as public toilets.

### Litter

Although there are LCC litter bins at intervals along the Victoria Park side of Victoria Park Road, these are often full to overflowing without the additional litter that would be produced by the proposal. Should the application be approved there should be conditions imposed such that the operators provide their own bins for customers to use which should not be emptied into the public litter bins and to litter pick the area around the trailer several times a day to minimise litter escaping onto the park and into the front gardens of the properties along Victoria Park Road.

# **Competitors**

There are numerous other permanent premises nearby selling food similar to that proposed, for example on London Road and Queens Road. There is also a near identical fixed food trailer operating only 500m away on Victoria Park Road opposite Hartopp Road.

#### **Permanence**


Much like the other food trailer on Victoria Park Road, this trailer would become a permanent fixture, never moving from one year to the next. As well as becoming an eyesore, this would be problematic when large events are held on Victoria Park, which often necessitate the closure of Victoria Park Road between Queens Road and London Road.

# **Anti Social Behaviour**

Clarendon Park is a predominantly residential area albeit with a local retail area at Queens Road, which tends to focus any noise and other anti-social behaviour in a small, predictable area. The proposal would create an additional focal point for people to gather and socialise each evening in an area where this currently does not happen, impinging on the right of residents to peaceful enjoyment of their home.

## **Conservation Area**

The location proposed is on the north west edge of Stoneygate Conservation Area, directly between the Conservation Area and Victoria Park. This would impinge on currently uninterrupted views across Victoria Park (itself Grade II listed) to the many other listed buildings surrounding Victoria Park including De Montfort Hall (Grade II), the Park Lodges (Grade II\*) and the Arch of Remembrance (Grade I). Supplementary planning controls that apply to Conservation Areas are there to ensure that the special architectural and historic significance of these areas are preserved or enhanced. Were this proposal subject to planning permission it is highly likely that it would be refused on the grounds that it would harm the character of the Conservation Area.
