# 1. Summary

1.1 This report outlines an application under the Licensing Act 2003 for a variation to an existing premises licence for The 72 Bar and Restaurant, 72 Brazil Street, Leicester and summarises the representations received. It also highlights the licensing objectives and the relevant parts of both the statutory guidance and the Licensing Authority's Licensing Policy.

# 3. Application and promotion of the licensing objectives

- 3.1 An application was received on 11 September 2024 for a variation of an existing premises licence for The 72 Bar and Restaurant, 72 Brazil Street, Leicester. A copy of the application is attached at Appendix A.

## Conditions to be removed:

Customers will not be permitted to consume drinks supplied by the premises, outside the licensable area marked on the site plan whilst stood up. Vertical drinking will not be permitted immediately outside the premises.

No more than thirty customers will be permitted to remain within the designated smoking area or other external space at one time between 10pm and closing to the public, with the exception of entry and egress.

A minimum of three Security Industry Authority (SIA) front line door supervisors will be deployed at the premises on Leicester City FC men's team, home matchdays.

Door supervisors will be deployed a minimum of two hours before the scheduled start and a minimum of one hour after the end of the match. They must remain on the premises during their deployment.

- 3.3 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section 16 of Appendix A).
- 3.4 The existing licence is attached at Appendix B.
- 3.5 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

# 4. Representations

- 4.1 A representation was received on 03 October 2024 from the Police. The representation relates to the prevention of crime and disorder, the prevention of public nuisance and public safety. The Police are concerned that the premises has only been open for three months and there have already been multiple breaches of the existing premises licence. A copy of the representation is attached at Appendix C1.
- 4.2 A representation was received on 07 October 2024 from the Noise team. The representation relates to the prevention of public nuisance. The Noise team are concerned that having an outdoor area will increase noise for nearby residents. A copy of the representation is attached at Appendix C2.
- 4.3 A representation was received on 09 October 2024 from the Licensing Enforcement Team. The representation relates to the prevention of crime and disorder, the prevention of public nuisance and public safety. The Licensing Enforcement team are concerned about the applicant requesting to remove the condition regarding SIA door staff from the licence. They have been in contact with the applicant and they have agreed to retain this condition. A copy of the representation and agreement is attached at Appendix C3.
- 4.4 The Planning Team are a Statutory consultee as part of the application process. They have not submitted a representation in relation to the application however have provided clarification on the status of the planning permission for the premise. They have confirmed:-

'The Class E use does cover all of the first floor on the inside. The application sought to install a canopy over the outside area and this was refused so this area should not be used as part of the restaurant.'

## 5. Conditions

- 5.1 The conditions that are consistent with the application and the representations are attached at Appendix D.
- 5.2 The Live Music Act 2012 and the Legislative Reform (Entertainment Licensing) Order 2014 amended the Licensing Act 2003 in relation to the provision of regulated entertainment. Certain entertainment does not require a licence subject to audience limits, between 08.00 and 23.00 hours each day. These exemptions may affect the application under consideration because conditions may not be imposed at this stage to control live or recorded music that is unregulated. However, if problems do occur as a result of that entertainment then conditions may be imposed to control such music in the future after a formal review.





#### Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or
  - ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

The responsible person shall ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
  - i) beer or cider: 1/2 pint;
  - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - iii) still wine in a glass: 125 ml;
- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

All individual(s) at the premises for the purpose of carrying out a security activity must

- (a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
- (b) be entitled to carry out that activity by virtue of section 4 of that Act.

officer from a responsible authority upon request.

The licence holder shall ensure that all Security Industry Authority (SIA) front line door supervisors or other persons engaged at the premises for the purpose of supervising or controlling queues or customers (paid or not) must wear high visibility tabards and/or high visibility SIA badge armbands whilst on the duty.

The licence holder will ensure that at least one operational audio and visual body worn camera is deployed at the premises and worn by either a member of security or staff, whilst the premises is open to the public on Leicester City FC men's home match days, two hours before the scheduled start and a minimum of one hour after the end of the match.

The licence holder will ensure body worn camera footage in both an audio and visual format is retained for a minimum of 31 days and made available to an officer from a responsible authority within fourteen days of a request.

The licence holder will promote and ensure that all front of house staff and Security Industry Authority (SIA) door supervisors employed at the premises are trained in public safety campaigns such as "Ask for Angela" or other similar schemes. 

I write in my capacity as Leicester City centre's alcohol licensing officer for Leicestershire Police, with delegated authority from the Chief Constable.

My representation to this major variation application is based upon the licensing objectives as per the Licensing Act 2003.

Leicestershire Police wish to submit a representation to this application, as it would undermine three of the four licencing objectives, if granted.

The premises is located on the junction of Brazil Street and Burnmoor Street in Leicester.

The premises is located on the first floor and can be accessed via a pedestrian door on Brazil Street and/or a vehicle ramp onto the roof top open air car park via Burnmoor Street.

The open-air car park is suspected to be owned by the applicant and overlooks Leicester Electricity Sports Cricket ground.

The immediate area consists of a mix of residential and commercial units. The nearest residential property is approximately twenty-five meters away on Burnmoor Street and slightly further afield on the other side of the cricket ground on Pavilion Close.

Leicester City FC's King Powder stadium is located a short distance down Burmoor Street on Raw Dykes Road.

On home match days, road closures are enforced outside the premises on the junction of Brazil Street and Burnmoor Street in order to prevent motor vehicle access. This is done so before, during and after the conclusion of the match for a period of time.

In May 2024, the applicant applied for a new grant resulting in representations being submitted by Leicestershire Police and Leicester City Council Noise & Pollution Control Team.

On the final day for representation's, the applicant's agent submitted an amended premises plan, in order to increase the size of the outdoor area. This would ultimately increase the size of the licensable area. The applicant was informed a new application would be required for the amendments, resulting in a further consultation period, so the proposal was withdrawn.

After the consultation period expired and ahead of the forthcoming hearing, the applicant via his agent agreed to reduce their operating hours, as well as agreeing to a number of additional measures in order to satisfy the police and council. Some of these were reflected in the police's signed agreements dated 12<sup>th</sup> June 2024.

On the 18<sup>th</sup> June 2024, the premises licence was granted for Kings Restaurant & Bar. (LEIPRM2053).

Therefore, the premises is currently licensed for the following licensable activities, with no seasonal variations permitted:

# The performance of dance, playing of recorded music indoors only and supply of alcohol on the premises only:

Sunday to Thursday from 11am until 11pm.

Friday & Saturday from 11am until midnight.

#### **Late Night Refreshments:**

Friday & Saturday from 11pm until midnight.

#### Opening hours to the public:

Sunday to Thursday from 11am until 11:30pm

Friday & Saturday from 11am until midnight.

Less than three months since the licence was granted and less than two months since the start of 2024/2025 football season, this major variation application has been submitted requesting a daily increase in operating hours, seasonal variations and the removal of specific conditions only added three months prior. The applicant also wishes to increase the size of the external of area to accommodate more customers.

The applicant wishes to increase the premises opening hours to the public on Friday and Saturday night by a further 30 minutes. Thus until 12:30am the following morning.

The applicant also wishes to remain open to the public until 2am following Diwali New Year, Christmas Eve and New Years Eve, with licensable activities including live music, recorded music, late night refreshments and the supply of alcohol being extended until 1:30am.

As of Monday 23<sup>rd</sup> September 2024, the premises has only opened twice to the public. This being Saturday 31<sup>st</sup> August and Saturday 21<sup>st</sup> September 2024.

On Saturday 21<sup>st</sup> September 2024, ahead of the Leicester City FC V Everton match at the nearby King Power stadium, PC Pritchard conducted a licensing visit at the premises. PC Pritchard spoke with the applicant and observed multiple breaches of its current premises licence. This was discussed further at the scheduled major variation application meeting on Monday 23<sup>rd</sup> September 2024.

Leicestershire Police believes the applicant has not built up a sufficient track record to prove themselves as a responsible operator as the licence was only granted three months ago and football season has only started less than two months ago.

Similarly, the applicant wishes to increase the size of the venue and increase the operating hours which ultimately increase the risks to the operator and the public whilst removing the majority of the safety measures only agreed to three months ago.

The application suggests that one member of security will be sufficient to control the premises, which consists of two entrances, inside and a large external area. The police strongly disagree with this proposal and consider this extremely dangerous and would ultimately put both customers and staff at risk of harm. Also, it is likely to result in crime and disorder both inside and outside the venue.

Leicestershire Police have some serious concerns about this application and respectfully request that the application is refused.

#### Please summarise your concerns about this application:

The premises is located on the junction of Brazil Street and Burnmoor Street. 72 Brazil Street is an old factory that is now a bar/restaurant.

The original application for this premises was made under the name Kings Restaurant and Bar (LEIPRM2053). Since then, the business has changed name to The 72 Bar and Restaurant.

The applicant has applied for a variation to their premises licence. They have requested that the condition "customers will not be permitted to consume drinks supplied by the premises, outside the licensable area marked on the site plan while stood up. Vertical drinking will not be permitted immediately outside the premises" to be removed.

The applicant wishes to expand the bar/restaurant floor space, by use of the outdoor area on the 1<sup>st</sup> floor which is on the Burnmoor Street side.

My concerns are that Burnmoor Street, although made up of a mixture of commercial units, also has many residential properties that back onto even more properties.

Noise from having an outdoor area with customers seated and customers coming out to smoke/vape has to potential to cause a noise nuisance to nearby residents, especially during the summer months when residents will have their windows open. Noise outdoors is much more difficult to control. I am not confident that the staff would have the powers to control this.

Furthermore, the application states that "we can't in good faith restrict the number of customers from walking into the smoking area with their drinks". This also gives me great concern in terms of managing customers.

They have also stated that they don't see the need for three SIA door supervisors and feel that this is excessive and are requesting for just one SIA door supervisor. This gives me even more less confidence that the staff are not going to be able to control the noise and the number of customers going out to the outdoor area.

## Please give further details of <u>why</u> you believe this application will have an adverse effect on the licensing objectives

I have strong concerns in having an outdoor area at this location. The area on the first floor is quite a large area, including a ramp for vehicles to drive up and park on the 1<sup>st</sup> floor. The ramp is not used for this purpose, however a large accumulation of people on the first floor and standing along down the ramp has the potential to cause noise nuisance/s.

From the detail outlined in the application. I am not confident that having one SIA door staff will be sufficient to control the number of people in the outdoor area including any noise that could be excessive. It is most likely the SIA doorman will be situated at the front entrance for the majority of the time.

The application does not state what times they intend to use the outdoor area. Having an outdoor area of this nature, so close to residential properties has the potential for the Noise and Pollution Team to be receiving complaints about noise, especially during the summer months, when residents will have their windows open.

As the evening progresses the background noise reduces, sound has the potential to travel further and it is highly likely that the residents living near-by could be affected by the noise generated from large groups of people sitting, standing or from just customers coming outside for a vape/smoke.

The premises has a licence for the provision of live music and provision of recorded music from 11:00-23:00 Sunday-Thursday and 11:00-00:00 Friday-Saturday.

I am concerned that the opening and closing of doors during times when live or recorded music is being played in the premises could also potentially cause a noise nuisance to near-by residents, this combined with the general noise associated with outdoor licenced premises of this nature increases the potential for noise complaints

to be received by the service.
The applicant also wishes to remain open for an extra half hour closing at 00:30. In my previous conversation with the applicant for the initial licence application. I had explained my concerns and came to an agreement with the applicant for a closing time to the public for 00:00.
I therefore, recommend that the application be rejected on grounds of public nuisance.

Please take notice that I am satisfied that allowing the premises to be used in accordance with the application would undermine the above stated Licensing Objectives and as such submit our representations.

#### Representations:

We would like to submit our representations for this premises application based upon the above stated licensing objectives.

The application is for a Variation of an existing Premises Licence LEIPRM2053 for the following activities:

Fri & Sat 11:00hrs to 00:00hrs

Playing of recorded music (indoors): Sun-Thurs 11:00hrs to 23:00hrs

Fri & Sat 11:00hrs to 00:00hrs

Late Night Refreshment (indoors and outdoors): Fri & Sat 23:00hrs to 00:00hrs

Supply of alcohol for consumption ON the premises only: Sun-Thurs 11:00hrs to 23:00hrs

Fri & Sat 11:00hrs to 00:00hrs

Premises opening hours: Sun-Thurs 11:00hrs to 23:30hrs Fri & Sat 11:00hrs to 00:00hrs

The premises opening hours will be changed to Fri & Sat 11:00hrs to 00:30hrs.

There will be no change to the other current licensing hours except for seasonal variations which have been applied for on Diwali and Diwali New Year, Christmas Eve and New Years Eve. The applicant has requested an extension of opening hours to 01:30hrs for each of the above licensed activities, with the premises closing at 02:00hrs.

The applicant has also proposed to increase the size of the venue and extend the licensed area to the outside car park area which could increase the capacity by another 50 persons when stood up.

In addition, the applicant has asked to remove the following conditions:

Customers will not be permitted to consume drinks supplied by the premises, outside the licensable area marked on the site plan whilst stood up. Vertical drinking will not be permitted immediately outside the premises.

No more than thirty customers will be permitted to remain within the designated smoking area or other external space at one time between 22:00hrs and closing to the public, with the exception of entry and egress.

The applicant has asked to change the following condition:

A minimum of three Security Industry Authority (SIA) front line door supervisors will be deployed at the premises on Leicester City FC men's team, home matchdays. Door supervisors will be deployed a minimum of two hours before the scheduled start and a minimum of one hour after the end of the match. They must remain on the premises during their deployment.

The applicant has made the following request:

The requirement of 3 SIA door supervisors is excessive and for a family friendly bar and restaurant we do not see the need for it.

On match days we will happily agree to having 1 door supervisor 2 hours before and 1 hour after the match as per their requirements.

The premises is located on the first floor at 72 Brazil Street in the Saffron Ward of Leicester. The premises is less than a quarter of a mile from the King Power Stadium.

At 11:00hrs on Monday 23<sup>rd</sup> September 2024, Elizabeth Arculus, Licensing Officer for Leicester City Council attended the premises accompanied by Jefferson Pritchard of Leicestershire Police. She was met by the applicant Darshan Sharma and his agent Anil Bhawsar.

At the start of the meeting it was disclosed by Mr Pritchard that several licence breaches had been observed during a recent Police Licensing visit on Saturday 21<sup>st</sup> September. It also emerged that the premises had only been open twice since the licensed was granted on 18<sup>th</sup> June 2024, both times on Leicester City matchdays.

The Licensing Authority believe that the changed condition will be inadequate from a public safety perspective, and that the original condition regarding the number of door supervisors must remain. We believe it is reasonable to have 3 SIA door supervisors especially considering that the premises will be utilising the outdoor area and the original capacity will be expanded. When questioned about this the applicant mentioned that there were plenty of police officers in the area on matchdays but it was explained that the police are not there to provide security for individual premises.

On Wednesday 2<sup>nd</sup> October Elizabeth Arculus approached the agent Anil Bhawsar via email to explain the Licensing Authorities position on altering the SIA condition. Mr Bhawsar confirmed that the applicant agreed to retain the condition.

The Licensing Authority do have concerns about the premises and the effects it may have on the local community, both business and residential. This relates to the detail of the operating schedule that has been applied for. The operating schedule is loose in laying out specifically how the applicants would uphold the licensing objectives.

We believe that with the amendments and additions shown below that the premises and applicant could promote the licensing objectives in line with conducting their business in a safe manner.

#### **Conditions Details:**

We believe the below additions/amendments of conditions in full, which we believe are reasonable, proportionate and enforceable, may assist the Licence Holder in upholding the licensing objectives.

We have detailed, for clarity, those that
