# 3. Traffic and Highways Update

- Rupert Bedder updated the meeting on the actions from the previous meeting, and on current developments.
- Concerns and complaints on pavement issues were raised and picked up by Rupert.
- Parking enforcement issues also raised, Rupert to arrange to investigate 'dropped curb' parking.

# Flooding Matters in the Ward -

- Rupert requested the addresses of properties affected by the floods. These will be addressed with the joint meeting and visit between LCC and the Environment Agency.
- Rupert explained to the meeting the role and responsibilities of the lead local flood authority (Section 19) Flood Act.
- Road Gullies, Drain Flooding, are the joint responsibility of LCC and Severn Trent.

# 4. Housing Update

- The meeting noted an update from Highways –
- Voids = 19 empty properties.
- Inter-agency working with ASB Team, Police, Housing, Cllr Aldred, resulted in the development and implementation of the Local Lettings Policy.
- Twelve Month probationary period can be extended to eighteen months.
- Housing to pay due diligence re Anti-Social Behaviour issues relating to housing residents.
- CRASBU holding Engagement Sessions, next meeting scheduled for, Wednesday 15<sup>th</sup> January 2025, at the community centre.

## 5. **Police Crime and Commissioner.**

- The chair welcomed Rupert Matthews, the Leicestershire Police Crime and Commissioner to the meeting.
- The Crime Commissioner set out the Police and Crime Commissioners role, as the elected official, tasked with setting out the way crime is tackled by the Leicestershire police.
- Mr Matthews provided a brief overview and then undertook a Questions and Answer session from the floor.
- Neighbourhood Watch Support and Liaison.
- Percentage of council taxpaid to the PCC role.
- How is the PCC proactively involved in crime and prevention.
- What percentage of funding spent in the Thurncourt ward.

# 6. **Local Policing Update**

- The meeting welcomed Sergeant Naomi Mitchell.
- Officers provided reassurances regarding the incident on Oswald Road in the ward resulting in a fatality.
- Ward Councillors offered condolences to the family and residents of the ward.
- Updates on drug patrols provided.
- Outcomes on knife crime arrests, stop and searches, and drug related offences provided.
- Police stats for the ward provided.
- Resident questions taken from the floor.
