Appendix A - City Warden Update

There have been over 8 reports of fly tips reported/investigated and notices given this month.

Abandoned skips have been investigated and reported for removal to great success.

Have reported numerous household items, liaising with cleansing which have been removed.

Dog fouling reports investigated, additionally, letters have been sent to addresses giving notice revolving the occupants' dogs leaving stool in nearby gardens/footpaths.

Community protection warning notices for untidy land and deposit on highways have been handed out and all have been complied to.

Interviews throughout the beginning of the year have been carried out for fly tip's in hot spot areas where evidence has been found, multiple Fixed Penalties issued.

Most of these issues have taken place on Aikman Avenue, I've noticed this month a **large** drop in waste being deposited by nearby apartments, particularly Fairburn House where most of the items were coming from. I'll continue to patrol this area and communicate with the housing officers.

Patrol for fly posting takes place weekly, so far so good.

Brex Court, Cokayne Road is often being patrolled as it was a dumping ground for waste, happy to report this area has remained clean for a few months since fixed penalties were issued.

Alleyways and back gardens/grass patches have been investigated, photos taken and communication made with housing/parks to resolve these issues.

Additional weekly patrol on foot and bike in all areas using tracking device.

Please bring any issues you are facing to the Council's attention by using the "Love Clean Streets app – Love Leicester." The app is easy to use, and you can report litter, fly-tipping, dog fouling or any other environmental problem. The advantage is that you can take a picture of the problem and upload it, tagging the location and including other details so the appropriate team can fix the issue quickly. Appendix B – Housing Update

Housing Update for Western Ward meeting 24th March 2025

Staffing – No issues.

Burns Flats –

- **Fire Safety Issues** – Works is constantly being carried out by Housing Officers and the Cleansing Team to ensure that all fly tipping is removed quickly e.g. large items mattresses or anything that could be set fire to. Assistant Housing Officers check that the shutters are down and locked on the bin stores to prevent bins being set alight.
- **Security Doors intermittently working** – although the system is now back up and running there are odd instances where tenants FOBs are failing, they can visit the New Parks Library to get a new FOB. All issues are being referred back to the Contracts Team in repairs. A presentation has been given to Housing staff on a proposed new system to replace the current one which is very old. We are awaiting an update on the outcome of this and a date for the new system to be installed.
- **Disabled parking availability to Bentburn / Crayburn House** – parking is not allowed outside of the Crayburn Rooms and the boiler house as access is needed to the boiler house and to allow BIFFA to empty the bin store there. If access is blocked, BIFFA won't empty the bin.
- **Fob not accessing washing room.** – there are a couple of laundry rooms which have had to be closed due to continuing vandalism, Housing are working with the Police, Community Safety & the Hub to identify youths who are accessing laundry rooms across the blocks. Currently it is not ideal but for blocks where the laundry is closed, the tenants have been provided with a FOB to another block with a useable laundry room. A FOB system that is included with the new Security Door system has been requested, we await an update on this.
- **Numerous complaints made concerning housing officer attitude** – if we have details of the specifics of these complaints we can investigate.
- **Anti – Social Behaviour** – a joint exercise with Housing and Community Safety has been carried out with the Hub, Police, STAR, & a few other services recently. Door knocks/Surveys took place on 11th March. An event was held at the Crayburn Rooms on 20th March as well to get an idea of the issues the residents are facing. Community Safety will collate the responses, and any necessary actions will be passed to the relevant departments to deal with.

Environmental Budget – The following projects should be completed by end of March; -

- **Deansburn House** – Internal Painting of block – this has been delayed due to demand of painting section from damp/mould cases, will now be completed by July 2025.
- **Deep cleans in Burns flats** – These have been carried out quarterly over the last 12 months and have helped in the appearance of the communal areas, tenants and residents like it so we will look to hopefully continue with this next year if funding is available.

We will be putting together a list of projects to put forward for the Environment Budget for 2025/2026. We have £66k to be shared out across the West District.
