## **Appendix A**

### **Rushey Fields and Parks Update**

Works are progressing with the new walking route at Rushey Fields Recreation Ground. Whilst the design work has been completed, the survey work has identified that repairs are required to the main path between Melton Road and the centre of the site due to trees lifting the surfacing and creating a safety hazard. Additional funding is being sought for these repairs so that there is a continuous new route around the park - this will mean that the original proposed walking path will not need to be valued-engineered or compromised in any way.

Two Parks cleaners that cover a third of Leicester's 6 main Parks, sports fields and pocket parks and their aim is to litter pick, bin empty twice a week and fly tipping is reported to Parks Rangers or City Wardens to investigate and cleared by Parks teams.

Community engagement signage and enforcement are used to tackle fly tip, littering and dog fouling.

Due to the increase in litter caused by unauthorised cricket on Rushey Fields and many other green spaces/parks including Cossington Recreation Ground, Spinney Hill Park and the high levels of complaints these areas are cleaned above and beyond our litter schedules.

Recently the recycling area on Cossington Street Recreation was decommissioned due to improper use.

## **Appendix B – Housing Update**

### **Housing repairs**

The figures below relate to LCC properties in the Rushey Mead Ward only.

- There are currently 5 void properties.
- During 2024-25 there were 763 repairs raised, of which there are 10 outstanding.
- During 2024-25 wait time for repairs were:
  - Category 1 – SLA is 24 hours: 13.9 hours average wait time.
  - Category 2 – SLA is 10 working days: 11.1 days average wait time.
  - Category 3 – SLA is 12 months: 3.09 months average wait time.

### **Tenancy management**

- This financial year we are working on improving the cleansing of communal area on some of the flats within the area, also we are currently assessing some of block to be consider for future painting scheme.
- We will be reaching out to local Cllrs in the coming months to explore any ideas they have for next year environment budget on our Housing areas.
