#### Appendix A - Highways Update

#### **Road Safety**

We have the proposed St Joseph's & Netherhall 20mph speed limit area in this year's program. The proposed scheme encompasses all remaining roads north of Netherhall Road, up to Keyham Lane West.

#### **School Streets**

As part of Clean Air Day, on the 19<sup>th of</sup> June, we closed Hazeldene Road to school traffic. These are the comments that we got back from Kestrel Mead Primary School:

"We got to walk with our friends to school today. It was fun." Year 1 child.

"It was the best day ever." Year 2 child.

"It was so quiet walking in this morning. It is a little hot, but we are sun creamed up ready for today." Reception parent.

"It has been really good the children have enjoyed it." Staff member.

Our monitoring of how the children travelled to school that week showed that on the day the number of pupils walking increased and that the number of pupils being driven or using the Park and Stride decreased on the day and that the day after there were still more children walking and less being driven than before Clean Air Day.

On that basis we would like to start conversations with the Ward Cllrs, the school, and the wider community to see if they would like us to trial the school street on a daily basis. We are also looking to locate suitable locations for new pedestrian crossing points on Scraptoft Lane between Brook Road and Radiant Road, subject to the usual consultation processes.

#### **Appendix B – Housing Update**

Tenancy Management are continuous working with our partner the Police and Community Safety to tackle the ongoing issues we are facing with anti-social behaviour on our estate and with this in mind. This year environment budget we are looking at security improvement on our maisonette within the Estate to help reduce the amount of ASB we face.

We will also be attending the 'Fun Day' event which is being organised in response to an increase in ASB and Crime issues at the Neighbourhood Centre in Netherhall.

The event is due to take place on the 13th of August 2025, 2-6pm.

We are also working to improve the surrounding areas of the Shop on Netherhall Road with our colleagues within Repairs and Estate and Building. Regular patch walks are happening within the area to closely monitor and address issue as they arise such as litter.

#### Appendix C - City Warden Update

The city warden service was all redeployed to work solely in the city center for the New Public Space Protection order. This was from 1st April until 14th July 2025.

The city wardens are still working in the city center on the PSPO until the end of September but on reduced numbers which has released officers to 2 days in their wards and they are working through the 3 months back log of jobs, and current issues this includes:
