# Appendix A – Traffic and Highways Update

- The TRO (Traffic Regulation Order) is aimed at making changes to the waiting restrictions around the junction of Glenfield Rd and Westfield Rd to help improve sightlines.
- In addition, we are still progressing with TRO proposals to introduce a section of one-way street on Tatlow Road alongside Braunstone Frith Primary School as you approach Liberty Road (similar to the temporary one-way we trialed when we did work to the verge here).
- Dovelands School remains high on our agenda, a more detailed update from the Active Travel Team.

## Appendix B - Housing Update

**Staffing** – No vacancies within the Team

### **Environmental Budget 2025/26**

There is £200k available again this year, it is shared across the 3 Housing Districts, so £66k each. This is then further shared between Wards in each District, so the West covers Western, Fosse, Westcotes, Abbey and Beaumont Leys.

The list of proposed projects was shared with all Councillors in the West District for comment/suggestion and final approval was given by the Lead for Housing, Councillor Cutkelvin.

Projects in the Western Ward – upgrade/installation of security doors to blocks at Dupont Gardens, this project was started a few years ago and initially was joint funded by the Safer Leicestershire Partnership, however each year further blocks have been put forward for funding, but other priorities have had to be considered so we are glad that we can continue with this.

Funding is being used for quarterly deep cleans of the Burns flats.

There is also a painting project across the City, and several of the blocks in the Burns flats and on Braunstone Frith have been put forward, we will give updates when we receive notification of when and where this may happen.

### **Burns Flats Action Group**

6 weekly meetings continued to be held with the Hub, Councillors, Police, Community Safety, Cleansing, Housing, Repairs and any relevant agencies tackle all issues being raised in the blocks. This is proving extremely invaluable in tackling cleaning issues, repairs issues with the heating, door entry system and lifts.

A cost exercise is being considered, and a further survey will be carried out around the usage of the drying rooms. Currently there are 3 closed due to ongoing vandalism and also the theft of a dryer. We are working with repairs to look at target hardening measures to prevent further vandalism to these rooms, residents who do not have access to their allotted laundry room are being given access to other available ones in other blocks.

### **Pop Up Sessions**

These sessions are still taking place on Tuesdays 11am – 3pm at the New Parks Library. They appear to be becoming popular with enquiries ranging across many departments, it is intended that other sections such as Income Management will be added into the sessions.

Alvin Raj has recently been appointed as the Tenant Engagement and Policy Manager and part of his role will be to recruit 3 Tenancy Engagement Officers, one for each District. The team will start to look how effective these sessions are, whether other sections should provide an officer and how the sessions can be developed. They will also work with community groups and Tenants Associations.

There are also sessions at the Tudor Centre on Tuesdays, Wednesday – Pork Pie Library and Brite Centre, Thursday - St Matthew's Centre and Thurnby Lodge Community Centre. All sessions are 11am – 3pm.
