Appendix A - City Warden Update

City Centre

City Wardens having instructed to enforce the PSPO in the City Centre, are carrying out patrols everyday enforcing against amplified sound, chuggers and unlicenced structures which has decreased significantly over the last few months.

Duty of Care checks for all businesses in the City Centre has begun, this is to ensure all businesses are disposing of their commercial waste in the right manner.

Started early morning patrols from 5am – 9am, to observe and tackle issues before footfall begins in the morning.

Out of hours Hot Spot Policing has begun where we patrol hot spot ASB areas across the city and report any issues to the Community Safety Team/Police.

2 x Fixed Penalty Notices issued to City Centre Businesses for illegal Fly posting.

Several abandoned commercial bins attracting more fly tipping reported by City Wardens to relevant companies who have now removed the bins.

Section 46 bins on Street letters are being issued to properties in City Centre housing new tenants who have moved in for the start of University Semester.

Two incidents of racist graffiti on landmarks in the city centre were reported personally, Cleansing were informed and removed both instantly.

Accumulation of waste on Private Land in the city centre was reported, CPW's ordered to remove the waste which was carried out by the land owners.

Clarendon Park

Started the Clarendon Park bins Monday 29th September stage 1 = 17 streets with none out on Oxford Road, Craddock Road, St Leonard's Road and Thurlow Road. 13 streets of bins, 156 bins out in total, all will receive section 46 notices.

This now starts the two months process it may take a bit longer due to the city centre PSPO and other wards, but this is a good start.

Queens road also had a few commercial bins out, will be looking into this and will be doing duty of care on the businesses in between the domestic bins project.

Appendix B - City Highways Update

Previous action points:

- Meetings due to take place with Severn Trent Water and LCC regarding recent flooding.
 - We have a meeting booked in with Severn Trent 10/10/25, to cover outstanding issues. An update on their investigations around Wyggeston College and Lorne Road is included on the agenda.
 - o We are aware that Severn Trent have not yet organised a meeting with Cllr Kitterick.
- Request to look into parking on pavements opposite the cemetery on University Road.
 - Our TRO team have recorded this on their request list. It has been assigned to an officer who will contact the ward councillors.
- Meeting to be arranged with relevant council officers to address parking issues.
 - Group Manager (Civil Enforcement and Traffic Regulations) will be contacting ward councillors to arrange meeting

Highways Maintenance Works

We continue to inspect the footways and carriageways around the ward and in the last 6 months have found actionable defects as follows:

- Carriageway 207 orders
- Footway 263 orders

Footway Maintenance Schemes

Fleet street started 22nd September for 10 weeks (120k listed as being funded from LTG pot)
 Total cost approx. 300k but unsure who is funding the remainder

Carriageway Maintenance Schemes

Avenue Road Extension resurfacing (Welford Road to Queens Road)

Carried out in the summer holidays

- London Road resurfacing (Mayfield Road to Evington Road) Carried out in the summer holidays
- South Gates Underpass Planned for 7th November
- Charles Street resurfacing (Halford Street to Humberstone Gate) Planned for November

Projects

- City Centre Bollard installations Bollard installation on Granby Street (junction with Northampton St) – start 27th October – operational towards the end of November
- Mansfield St/Abbey St junction changes to allow 2 lanes out of Mansfield St with one lane specifically for access into Garden St – on site from 19th October to 14th November
