Appendix A – Local Plan Update

Update on Local Plan: Current Position and next steps

The six week consultation ([Leicester Local Plan – Main Modifications representations - Leicester City Council - Citizen Space](#)) noted in the minutes of your last meeting has ended, and all responses submitted by councilors and others have been forwarded to the Planning Inspectorate for them to review and consider the next steps.

The next step will be a letter from the Inspectors which will set out whether any further actions or consultation is required at this stage, or if the Council can proceed to adopt the plan.

The decision to adopt the plan would be for Full Council to take. If approved, the principle of development of sites in the Plan will be established, but development will not proceed without the submission and further consultation on detailed planning applications for the sites in due course.
