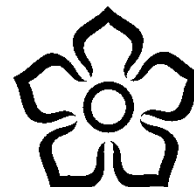

## **Appendix A – Pride in Place Update**

The Pride in Place Programme (PiPP) is a government-funded regeneration programme which empowers local people to shape the future of their neighbourhoods. Neighbourhood Boards, led by independent Chairs and comprising residents, businesses and partners, will determine how up to £20 million of funding is invested over a ten-year period.

In Leicester, three areas have been identified by the Government to receive the funding. Thurnby Lodge, which includes parts of Netherhall, is one of the areas. The other two areas are Eyres Monsell and Braunstone Park West.

The Programme is in the foundation stages now. We're recruiting Independent Chairs this month, who will form Neighbourhood Boards over the coming weeks. We will also start community engagement with local communities and residents as this feedback is vital to helping the Board to shape the plans for the area and how the money is spent. We will communicate more about the opportunities to get involved soon.

## **Appendix B – Netherhall Shops Renovation Update**

Work on the front canopy, In progress at 50 % completion. Work to renovate the void shop units so they can be relet. Olivetti requires access to the site to commence work. Work to improve security for tenants of flats. Work on waterproofing to ensure water does not penetrate shop units.

## **Appendix C – Highways Update**

### **Actions from previous meeting:**

- Is there Speed Restriction for Upper Hall Close / Cardinals Walk
  - The area is part of the St Joseph and Netherhall 20mph scheme, but there are no traffic calming measures proposed for these particular roads. The works around St Josephs school are programmed for the upcoming school summer holidays.
- Netherhall Road near the shops (Opposite side of the shops) no signs on the road for the bus stop, so bus stops in the middle of the road, cars parked in the bus stops further up on Netherhall Road
  - We are aware of issues across the City with bus stops being obstructed. Where there are existing bus stop markings on the ground but no TRO plate, we are looking to mount appropriate bus stop clearway plates. We took delivery of 50 plates last week to make a start on this.
  - If ward councilors are unanimously supportive of marking 19m bus stop clearways / enforcing with TRO plates on Netherhall Road and are happy to put this in an email to [busstopinfo@leicester.gov.uk](mailto:busstopinfo@leicester.gov.uk), I'd be happy to look at putting this into the first tranche of works as we're still formulating our proposed program of works.
- Pedestrian crossing on Scraftoft lane near Nuffield hospital is the only one, will there be more on Scraftoft Lane.
  - Following consultation, LCC will be installing pedestrian crossing facilities at two locations on Scraftoft Lane. These locations have been long-standing requests and were identified as high priority in our 2024-2025 assessment. Both crossings will help local people reach local shops and services and help families on the walk to school journey. Work will start in June:
  - A raised junction table will be installed on Scraftoft Lane at the Brook Rd/Parkstone Road junction. The raised table will slow approaching traffic and there will be dropped kerb crossing points with tactile paving at all 4 arms of the junction, providing easier accessible crossing for those with prams, wheelchairs, or reduced mobility.
  - A zebra crossing will be installed on Scraftoft Lane, just east of Compass Road.
- Missing speed ramps (3) and double yellow lines not on Netherhall Road, where it has been resurfaced. Also, old speed ramps need replacing on Netherhall road.
  - The missing speed humps on Netherhall Road will be installed over the summer.
  - With regards to the missing yellow lines - could you please provide exact locations, as we believe that they have been put back correctly in each phase carried out.
- No pedestrian crossing near Kestrel Mead School near Hazeldene Road
  - There is a request for Maidenwell Ave on the pedestrian crossing request list. (All the crossing requests are assessed annually to determine the top priorities. Due to limited resources, only the highest priorities are taken forward to build).
  - Consultation will be taking place on measures to reduce traffic around Hazeldene Road for the school run.
- Armadale Green, lights on either side of the green are covered by a tree, and lots of weeds.
  - This has been passed on to our housing department who are responsible for the area.
- Parking issues around Nirvana football club.
  - Our Traffic Regulation Team have this request for parking restrictions around the football club, on an upcoming batch of possible TRO's.

- We have some concern about the effect on other highway users/residents of introducing such restrictions, but this will come out during our consultation with ward Cllrs, residents, and others, which is all part of the TRO process.

### **Highways Update and Upcoming Works**

We continue to inspect the footways and carriageways around the ward and in the last 6 months have found actionable defects as follows:

- Carriageway – 120 orders
- Footway – 69 orders

Hamilton Lane (County boundary to New Romney Crescent) is to be resurfaced at some point over the next three months. Residents affected will be lettered prior to a start on site.

## **Appendix D – Housing Update**

The local lettings policy which was introduced in September 2025 is still in place and having the desired outcome which means we double vet potential tenants.

We still have some way to change behavior, but it is key that residents keep reporting these issues, our neighborhood housing officers regularly conduct patch walks and identifying issues with ward Cllrs and other service areas to improve litter issues, repairs to communal areas and ground maintenance works.

We have completed work on Netherhall flats, for the introduction of better lighting and enhancing the areas to improve by tackling litter, weeds, and moss.

We will be carrying out painting contracts for internal and external communal areas and due to start early 2026.

We are now exploring new environmental projects for 2026 ranging from £1000 - £20,000 to enhance the area further, if you do have any recommendations or suggestions, we will welcome ideas.

## Household Waste Duty of Care

This is to remind residents of your responsibilities for the disposal of the waste from your property. The waste (Household Waste) Duty of Care (England & Wales) Regulations 2005 state that householders are required to take reasonable measures to ensure that their household waste is passed on to an authorized person.

If you wish to use one of the Community Recycling Centers across the City then you must ensure that only the correct waste is deposited, and the waste must be placed within the containers. Any waste left outside of containers or on the Highway is considered as Fly-Tipping which is a Criminal Offence under S33 of The Environmental Protection Act 1990.

Leicester City Council also provides a bulky collection service for residents of the city. All householders are entitled to one free collection of up to five items of Bulky material every two months. Householders will be charged for the removal of over five items, and the charge will depend on the number of items collected. This will be advised when the request is made.
