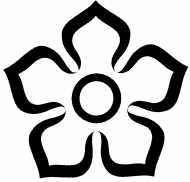

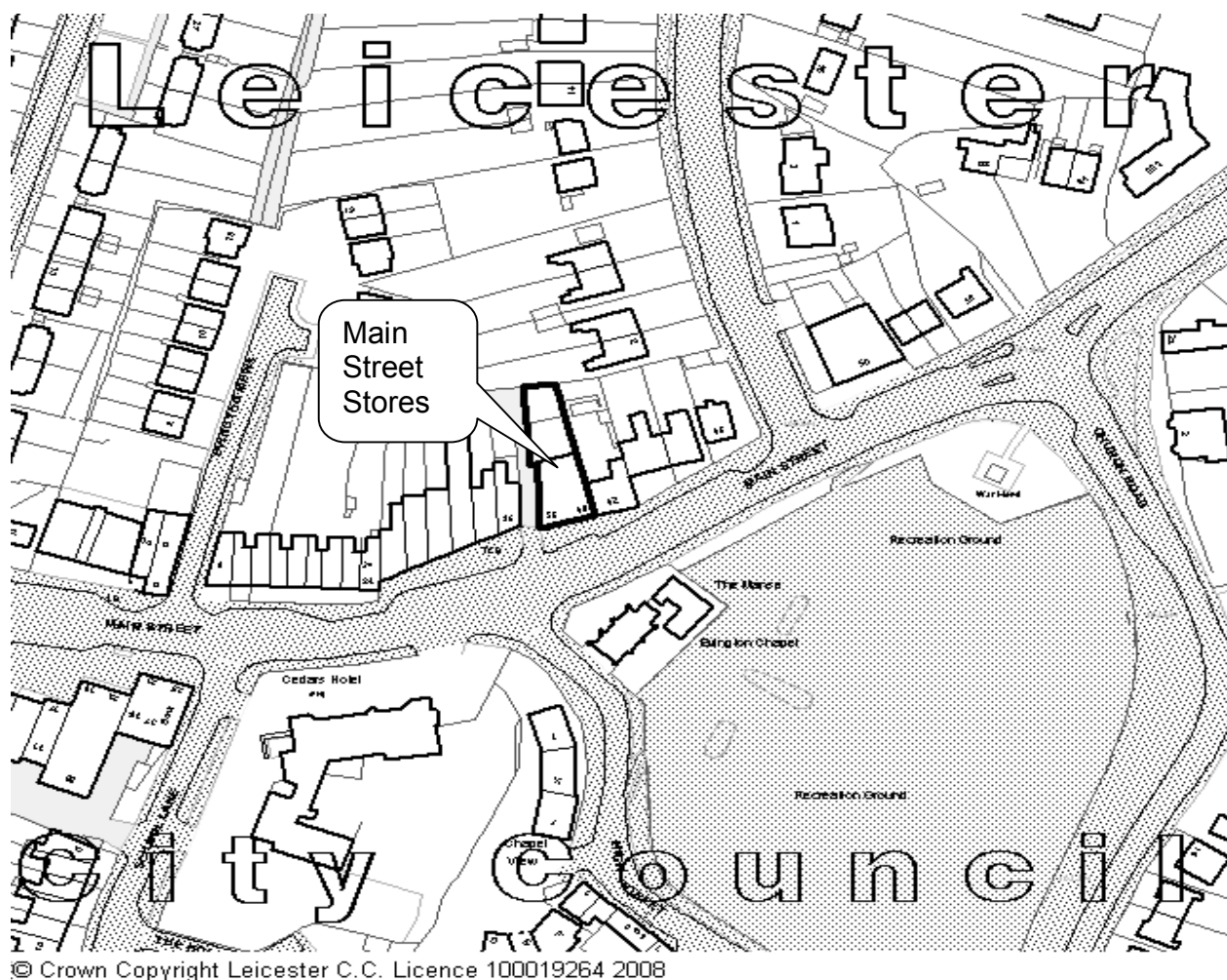

3. Summary

- 3.1 This report outlines an application for a new premises licence for 38-40 Main Street, Evington and summarises the representations received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

5. Application

5.1 An application was received on 24 May 2010 from Mr R Aggarwal for a new premises licence for 38-40 Main Street. A copy of the application is attached at Appendix A.

5.2 The application is as follows:

6. Steps to Promote the Licensing Objectives

6.1 The steps the applicant proposes to take to promote the licensing objectives are set out in

the operating schedule (see section P of Appendix A).

- 6.2 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

7. Representation

- 7.1 Representations were received between 8 June and 21 June 2010 from 13 local residents and 1 local business. The representations relate to the prevention of crime and disorder, the prevention of public nuisance, public safety and the protection of children from harm. The local residents and business are concerned that granting a licence to this premises to sell alcohol will increase disturbance and anti-social behaviour in the area. Copies of the representations are attached at Appendix B1-B14.

8. Conditions

- 8.1 The conditions that are consistent with the operating schedule are attached at Appendix C.
- 8.2 The case of Bristol Council v Bristol Magistrates' Court concerned conditions imposed by a licensing authority. This case reiterates that any conditions imposed by a licensing authority must be necessary and proportionate with regard to the promotion of the licensing objectives, and must not duplicate duties already imposed by other legislation.

I am writing to object to an alcohol license for 38-40 Main Street, Evington. The shop was formally Morland Kitchens.

The site is opposite the Village Green. Selling cheap alcohol will encourage people to buy and drink on the Village Green and cause a public nuisance with subsequent litter - for example - empty bottles thrown on the flower bed that has been provided and maintained by the community.

Also people drinking on this site means that children are at risk from possible anti-social behaviour caused by alcohol.

When there was a Bargain Booze shop in the village (very near 38-40 Main Street), young people from the Youth Club were attracted by it and the older youths (18-19) role modelled drinking behaviour to younger members - more young people were leaving the club to walk around the Village. The licence holder shall introduce a policy requiring photographic identification prior to the sale of any age restricted product.
The licence holder will ensure that CCTV is installed and maintained on the premises.
The licence holder will ensure that external lighting is provided in the car park area of the premises.
