We hope each year, to provide around eighteen male and female coaches (16-21 years old) with the opportunity to gain their Football FA Level 1 and 2 qualifications, inside a structured and professional setting. In return the young coaches will commit 50 hours of their own time to assisting the LSFA with coaching work inside schools and the LSFA

Representative teams. The money will be spent on paying for the FA qualifications, equipment, uniforms and small facilities cost (this will allow the association to offer continued support and training sessions through the year).

In time the coaches will be shared out amongst sixteen inner city schools that the LSFA is responsible for. At this time it is intended to pilot this through the following schools:

- Rushey Mead
- Soar Valley
- Judgemeadow
- St Pauls
- City of Leicester

The coaches will assist teachers with training sessions, on match days as referees or coaches and in any another capacity they can. Unfortunately at the moment teachers don't have the time to run school teams and that is letting down a large number of talented footballers and those that want to learn the game. We hope that by providing coaches to the schools under our supervision some of the work can be lifted from the teachers to help make the experience a lot easier and therefore more attractive to teachers.

This will also benefit the young coaches, both male and female, as they will be able to work inside the school system and gain a great deal of experience working with children, brilliantly references for work, College or University. They will be able to go into their old schools and local areas to make a difference in a community they have an association with, creating positive young role models for the school children to look up to. The younger we can start teaching coaches and allowing them to interact with the young people the quicker they are going to turn into good experienced coaches.

Finally the biggest benefactor will be the school children who will have more opportunity for physical activity, school interaction, local role models and hopefully more fun.

We have already qualified ten FA Level 1 coaches and a further five FA Level 2 coaches this season who have completed volunteer hours working for the association as Rep Team coaches. We hope to have this scheme rolled out early in the new school year and coaches inside these selected schools by October.
