3. DECLARATIONS OF INTEREST

The first main item on the agenda is Declarations of Interest where Councillors have to say if there is anything on the agenda they have a personal interest in. For example if a meeting was due to discuss a budget application put forward by a community group and one of the Councillors was a member of that group, they would not be able to take part in the decision on that budget application.

Councillors are asked to declare any interest they may have in the business on the agenda, and/or indicate that Section 106 of the Local Government Finance Act 1992 applies to them.

4. MINUTES OF PREVIOUS MEETING

The minutes of the previous Humberstone and Hamilton Community Meeting, held on 17 February 2010 have been previously circulated and Members are asked to confirm them as a correct record.

This next part of the agenda covers items where input from you on issues that affect your community is welcomed.

5. LOCAL BUS SERVICES

Julian Heubeck, Public Transport Co-ordinator, Leicester City Council and representatives from Thurmaston Bus, operators of the 52 Bus service, will be attending the meeting to discuss the provision of local bus services.

6. YOUTH SERVICES

Representatives from the City Council Youth Services division will be attending the meeting to discuss Armadale Youth Centre and youth provision in Hamilton.

7. POLICE UPDATE

Sergeant Dwight Parker and PC Alex Catlow from Keyham Lane Police Station will be attending the meeting to give an update on local policing issues.

8. CITY WARDEN

Charlotte Glover, the new City Warden for Humberstone and Hamilton Ward will be attending the meeting to introduce herself and give an outline of the range of work she is expecting to undertake.

9. HUMBERSTONE CARNIVAL

To receive an update on Humberstone Carnival.

10. BUDGET

Councillors are reminded that they will need to declare any interest they may have in budget applications, and/or indicate that Section 106 of the Local Government Finance Act 1992 applies to them.

The following bids have been received for Community Meeting funding and are summarised as follows: -

	Amount Requested	£
i) <u>Police Bicycle</u>		500
To provide the Humberstone and Hamilton Ward Neighbourhood Policing Team with a bicycle and equipment. The cycle will be used by the recently increased team to achieve better response times and greater Police visibility in the area, as well as give the ability to patrol alleys and footpaths. The bicycle will be marked as a 'Police' cycle and carry acknowledgement to the Community Meeting. Similar bids have been made to other Community meetings across the City.		

- ii) **The Unit Youth Project** **1,685**
 A bid to part fund The Unit's summer programme for 2010 that ran from 19th July to 31 August. Due to unforeseen circumstances 2 separate bids were submitted earlier in the year but were not processed, this current bid is therefore a retrospective bid. The Community Meeting should also be aware that, due to funding difficulties the lease on The Unit has expired and Hope Hamilton Church has not renewed it and the equipment used by the Youth Project has been put into store for the time being.
- iii) **Skips for Residents Bulk Rubbish** **1,080**
 A bid to fund the provision of skips for the use of residents for the disposal of bulky rubbish. Further information has been sought as to how the scheme will be publicised and whether the scheme is available to all residents.
- iv) **Leicester Dribblerz basketball Project** **2,344**
 A bid to provide an extended young people's arm to the already established senior section of the Leicester Dribblerz Basketball Club, an idea developed by the youth element of the Club through sessions delivered at Hamilton Community College. The Club to provide opportunities for young people to participate in Basketball through local organised coaching and the project will be based at Hamilton Community College. The Junior Dribblerz have already made progress by electing officers within the Club and these junior officers will be mentored by senior members to develop their skills as young leaders.
- v) **Essensual Rejuvenation Youth Pod Village** **1843**
 A bid submitted to assist the hosting of a Community Pod Village event on 16th August 2010, in partnership with local organisations and community groups. The Pod Village initiative was new and had been piloted in the Braunstone area with huge success. The bid was submitted in June and, despite numerous attempts to contact the applicants for further information no further contact has been made and it is doubtful whether the event actually took place.
