### MEMBERS OF THE PUBLIC TO NOTE

The Committee is recommended to consider the following reports in private on the grounds that they contain 'exempt' information as defined by the Local Government (Access to Information) Act 1985, as amended and consequently that the Cabinet makes the following resolution:-

"that the press and public be excluded during consideration of the following reports in accordance with the provisions of Section 100A(4) of the Local Government Act 1972, as amended, because they involve the likely disclosure of 'exempt' information, as defined in the Paragraphs detailed below of Part 1 of Schedule 12A of the Act, and taking all the circumstances into account, it is considered that the public interest in maintaining the information as exempt outweighs the public interest in disclosing the information "

#### Paragraph 11

Information relating to any consultations or negotiations, or contemplated consultations, or negotiations in connection with any labour relation matter arising between the Authority or a Minister of the Crown and employees of, or office holders under, the Authority.
