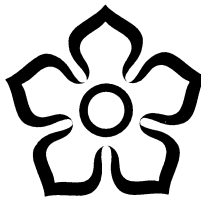

“Thank you my Lord Mayor and can I join others in congratulating you on your election to the office of Lord Mayor of this Great City and also join them in wishing you the very best for the year ahead and the duties that you will perform on behalf of this Council and its City.

But of course, I'm moving a motion of thanks to the outgoing Lord Mayor and on behalf of the whole Council and the many who he has met and worked with over the last year, to express our sincere thanks to Councillor Kamal for his service as Lord Mayor and for the work that he has done as the first

citizen of our great City.

Colleagues I think will know that Mustafa has served the City for many, many, years and indeed has been associated with this Council for the best part of two decades. As a Ward Councillor for most of that time, as deputy leader for five of those years, including a period as the deputy while I was the leader of the Council; they will have been aware that his experience, his knowledge and his love of our City have been expressed on many occasions and have developed during that time and have served him well during his year of office as our Lord Mayor.

During these 12 months, he has worked tirelessly to represent and to promote our great City. After starting the year with the opening of the 'Highfields Family Fun Day', Councillor Kamal went on to attend an astonishing 339 civic engagements. That's a truly remarkable achievement by any standards, but I think and I'm sure he won't mind I'm mentioning this, that considering the health challenges he has faced during the year personally, has been a very clear indication that not only his love for this city, which I have mentioned, but also to his determination and courage that all who have known him have admired.

There have been other highlights during the year, he has attended two Royal visits during the year; The Earl of Wessex and the Duchess of Gloucester. He's carried out hereditary Freemen ceremonies throughout the year, which have seen 24 people appointed as hereditary Freemen including a lady of 106 years; and a number of formal receptions have been hosted including many for the fantastic sporting achievements that have graced our City and its teams over this year including of course the very particularly enjoyable occasion of the Award of the 'Freedom of the City' last month to 'Leicester Ladies Hockey Club'.

Mustafa as our Lord Mayor has embraced the true diversity of our City, at the last count he visited over 29 faith organisations including a variety of Mosques, Mandirs', Gurdwaras', Churches and other places of worship. And of course he has, I think, taken particular pleasure at presiding over the appointment of 10 Honorary Alderman, some of whom I am pleased to see here with us this evening during the year, and have entertained them after that appointment with, I understand, a very enjoyable afternoon tea and it's very good to see that as a result of those appointments many of them not just here this evening, as I have said, but also participating regularly in civic events which of course helps to spread the burden of civic responsibility in the City.

Throughout the year, 9 people or groups have been recognised with Honoured Citizen Awards and a number of lunches have been provided for vulnerable and homeless people in and within this City by one of the particular winners of that or two of the particular winners of that; David Hartshorn and Ian Bremner of the 'Case Restaurant' who I think we were all delighted to see were given that award by Mustafa during his year of office.

All of this, that I've described is in addition to the numerous charity events that Councillor Kamal Mustafa has tirelessly attended to raise funds for his appeal which of course has this year been the backing of the 'Macmillan Cancer Support Charity'. It's an appeal that has been well supported by a number of local businesses and we're very grateful, I know, for what they have done to help support the Lord Mayor in raising the very substantial sum that he had achieved.

I think my Lord Mayor that it is perhaps worth paying tribute to those who have supported Mustafa as our Lord Mayor and no doubt he will be saying a few words himself on this subject, but throughout the time as Lord Mayor he has of course had the support of the Deputy Lord Mayor, the High Bailiff and, as has been mentioned, the particularly important support of Fiona, who as his consort has done such a magnificent job with him.

As I said in the beginning, Mustafa has served this City for many years, so of course he had some idea of what to expect when he took the Chair at our meetings here in this Chamber. But I think all of us who have served in this Chamber while he has been in the Chair have been enormously impressed by the dignity, the fairness, the tact and the good humour of which he's carried out those duties and we are very grateful to him in that capacity as well as what he has done out and about in the City.

I think my Lord Mayor, in moving this resolution of thanks, it is right that now together we celebrate the service of Councillor Mustafa Kamal as the Lord Mayor, as the first Citizen of this great City of Leicester and thank him for his hard work, his commitment and the dignity that he has brought to that office throughout his year in the Chair of our proceedings here.
