1. Policy developments of strategic significance relating to the above Terms of Reference.
2. Such other matters as the Committee may from time to time reserve to itself for decision.

LICENSING SUB-COMMITTEES

TERMS OF REFERENCE

The Terms of Reference of a Licensing Sub-Committee shall include the functions of the Licensing and Public Safety Committee with the exception of the consideration of policy issues, which the Licensing and Public Safety Committee has reserved to itself.

MATTERS RESERVED TO THE LICENSING ENFORCEMENT SUB COMMITTEE

1. Applications for a licence, consent or permit where a representation had been received from a ward councillor, a member of the public or an external organisation. (Excluding the Licensing Act 2003 and Gambling Act 2005).

2. Decisions required under the Licensing Act 2003 or the Gambling Act 2005 where the Director of Local Services and Enforcement considers that the existing policy does not provide sufficient clarity on determining the application and/or where it would be more appropriate for the application to be determined by the Sub-Committee.

All matters within the Terms of Reference of a Licensing Sub-Committee which are not reserved to Full Council, the Licensing and Public Safety Committee or a Sub-Committee as stated above, are delegated to the Director of Local Services and Enforcement.

N.B. The City Council's Constitution Council Procedure Rules 4 4 (i) (iv) states that decisions which, in the opinion of the Monitoring Officer, are of a quasi-judicial nature, which includes the decisions of a Licensing Sub-Committee may not be the subject of an Objection.

19. CHAIR FOR THE MEETING

25. REVIEW OF THE LICENSING ACT POLICY

The Director of Local Services and Enforcement submitted a report requesting Members to comment upon the proposed policy and special policy on cumulative impact to assist Council when setting the policy for 2016-2021.

The Committee were previously asked to comment upon the policy in August 2015, and requested to see the comments received as part of the public consultation. These comments were appended to the report together with officers' responses.

The main changes to the Licensing Policy were:-

Paragraph 7.8 - The licensing authority recommends that proper incident recording systems are in place.

Paragraph 7.13 - Recognises that it may be appropriate to carry out a risk assessment where events promoted by a third party or which are not part of the usual business of the premises are to take place.

Paragraph 7.14 – Sets out the steps that the licensing authority would expect to be taken to prevent crowd disorder at boxing events.

Paragraph 9.1 – The licensing authority recommends that off-licences in areas associated with problem street drinking take certain steps to prevent problems occurring.

Paragraph 10.6 – The licensing authority recommends that a risk assessment is undertaken and the police are informed about events aimed at children in premises which normally sell alcohol.

It was also suggested that the Policy should have a Foreword which would provide an opportunity to set out the Council's views on issues that would not normally be included in the policy, such as a vision, aspirations or a desired direction of travel for licensed premises in the City. The foreword would need to contain a clear statement that it did not form part of the licensing policy in order to prevent it being used as the basis for a potential challenge to a decision which had been taken in accordance with the licensing policy and the licensing objectives.

RESOLVED:

- 1) That the Council be informed that the Committee supports the draft Statement of Licensing Policy and recommends it be adopted.
- 2) That the Committee supports the inclusion of a Foreword to set the vision, aspirations or a desired direction of travel for licensed premises in the City provided it contains a clear statement that it does not form part of the licensing policy to prevent it being used as the basis for a potential challenge.

26. REVIEW OF THE GAMBLING ACT POLICY

The Director of Local Services and Enforcement submitted a report seeking the Committee's views on the Gambling Policy for 2016 – 2019 prior to its approval by Council.

It was noted that the new Gambling Policy for 2016-19 was required to be published by 3 January 2016.

It was also suggested that the Policy should have a Foreword which would provide an opportunity to set out the Council's views on issues that would not normally be included in the policy, such as a vision, aspirations or a desired direction of travel for gambling premises in the City and the Council's views on Fixed Odds Betting Terminals. The foreword would need to contain a clear statement that it did not form part of the licensing policy in order to prevent it being used as the basis for a potential challenge to a decision which had been taken in accordance with the gambling policy. The Committee also supported the development and publication of a local area profile.

RESOLVED:

- 1) That the Council be informed that the Committee supports the draft Statement of Gambling Policy and recommends it be adopted.
- 2) That the Committee supports the inclusion of a Foreword to set the vision, aspirations or a desired direction of travel for gambling premises in the City provided it contains a clear statement that it does not form part of the gambling policy to prevent it being used as the basis for a potential challenge.
- 3) That the Foreword should contain a specific reference to the Council's views on stakes for Fixed Odds Betting Terminals.

Outcome of appeal against refusal of premises licence - Licensing Act 2003
Candle Rooms, 25 Gravel Street, Leicester

Report of the Director of Neighbourhood and Environmental Services

1. Purpose of Report

- 1.1. To inform the Licensing and Public Safety Committee of the outcome of a recent appeal.

2. Recommendations

- 2.1. Members are asked to note the report.

3. Background

- 3.1 An application was received from Mr A Madlani on 17 March 2016 for a new premises licence under the Licensing Act 2003, for Candle Rooms, 25 Gravel Street, Leicester, LE1 3AG. Gravel Street is within a cumulative impact area.
- 3.2 Leicestershire Police made a representation on the grounds that that granting the application would add to the existing late night problems in the city centre by increasing the capacity of licensed premises within the cumulative impact zone and failing to promote the licensing objectives.
- 3.3 As a result of the representation, a hearing took place on 11 May 2016. The panel decided to refuse the application and the formal wording was as follows:

The reason for the decision after considering the application carefully and also the representation made on behalf of Leicestershire Police was that the application had not demonstrated that the grant of the licence with or without conditions would not add to the existing problems in the Cumulative Impact Zone. The grant of the licence would they feel undermine the promotion of the licensing objectives of preventing crime and disorder, preventing public nuisance and public safety. The application is accordingly refused.

- 3.4 Mr Madlani appealed to the Magistrates' Court.

4 Appeal

- 4.1 The appeal was heard at Loughborough Magistrates' Court on Wednesday 31 August 2016. Evidence was given by the appellant and by PC Webb of Leicestershire Police.
- 4.2 The Magistrates dismissed the appeal and awarded costs of £2,000 to Leicester City Council. The decision is attached in full at Appendix A.

5 Financial, Legal and Other Implications

Ashik Madlani(Candle Rooms) V Leicester City Council
Loughborough Magistrates Court
31st August 2016

1. The Court is dealing with an appeal by Mr Ashik Madlani, the appellant, against the refusal of the Leicester City Council to grant premises licence in respect of the Candle Rooms, 25 Gravel Street Leicester. The premises are situated within the Churchgate Cumulative Impact Zone (CIZ) of Leicester City Centre.

Background

2. In February 2005 Leicester City Council introduced a special policy on cumulative impact in the Churchgate area which refers specifically to on and off licences. This creates a rebuttable presumption, in the event of representations being received, that an application for a new premises licence will be refused, unless the applicants can show that their premises are unlikely to add to the problems of saturation.
3. The appellant acquired the premises in January 2016 and applied to Leicester City Council for change of use of the premises from a shop to a Function Suite. This application was successful and the Court refers to the Planning Permission, Particulars of Decision at p 20-22 of the bundle. It is made clear in the particulars of decision that the grant of planning permission does not obviate the need for permission under other Regulations. P21
4. The appellant intends for the premises to be used exclusively for private events (mainly Weddings, Asian primarily and corporate events). The premises have a maximum capacity of 500 guests with a front entrance onto Candle Street and a rear exit leading to a private car park with a capacity of approximately 80 parking spaces.
5. The appellant applied for the grant of a premises licence by application dated 11th February 2016, this is contained at p29-50 of the bundle. The application sought a 24 hour licence for 7 days a week with permission for all licensable activities being sought p 32 part 3 of the Operating schedule.
6. A relevant representation was received from the police on 8th April 2016 (p51-52 of the bundle). The representation related to the prevention of crime and disorder, the prevention of public nuisance and public safety. The police were concerned that the appellant had made no reference to the premises being within the Churchgate CIZ and had not addressed this in the Operating schedule of his application.
7. The application for the premises license was refused by the licensing Committee on 11th May 2016. The appellant was informed at the Hearing and also in writing *the reason for the decision after considering the application carefully and also the representation made on behalf of Leicestershire police was that the application had not demonstrated that the grant of the licence with or without conditions would not add to the existing problems in the CIZ.. The grant of the licence would they feel undermine the promotion of the*

licensing Objectives or preventing crime and disorder, preventing public nuisance and public safety.

8. Since the decision of the Licensing Committee in May 2016, a number of conditions have been proposed by the appellant which he submits deals with any concerns which may persist in relation to the location of the premises within the CIZ and the adding to the problems of saturation. These conditions are contained at paragraph 26 a) –f) of the appellants' skeleton argument.
9. The police have considered the proposed conditions and have concluded that they are in their view *insufficient to address the issues within that area*. P66-67 of PC Webb's statement. The Conditions were also referred to the licensing committee who were not prepared to revise their decision.

The law

The appeal is a de novo Hearing of the application based on the evidence now available before the Court.

The case of R (Hope and Glory Public House Ltd) V City of Westminster Magistrates Court 7 ors [2011] makes it clear that the court should have close regard to the decision made by the Licensing Authority. This is reaffirmed in the case of Sagnata Investments Ltd V Norwich Corporation [1971] QB 614 that not only should the Court of appeal pay close regard to the decision but that the decision should not lightly be reversed.

The burden of proof rests with the appellant on the balance of probabilities.

The Court's paramount considerations are the Licensing objectives contained at para 2.2 p95 of the Leicester City Council statement of Licensing Policy p93 onwards. These are:

1. The prevention of crime and disorder
2. Public safety
3. The prevention of public nuisance
4. The protection of children from harm

These objectives carry equal importance.

In relation to the policy on Cumulative Impact this is set out at para 4 p97.

Judgment

The Court heard evidence from PC Webb and Mr Madlani. Both had submitted additional statements. PC Webb also provided a log of reported incidents occurring in the night time economy hours in the CIZ between July 2015 and June 2016. PC Webb stated that this did not include spontaneous incidents. Although the Court accepts that not all the incidents resulted in crimes being recorded each one required police resources.

We agree with Counsel for the appellant that the key issues are:

1. What is the problem within the CIZ; and
2. Will the grant of a license increase those problems?

In our judgment it is clear from the evidence presented by the Local Authority that there is saturation of licensed premises within the Churchgate CIZ. This results in an increased number of alcohol related incidents.

The addition of a significant number of extra people into licensed premises within the CIZ albeit attending private events will in our judgment increase the risk of crime and disorder incidents. The concern for the court is the exiting of these guests into the locality which is already saturated which is likely to increase the potential for alcohol related incidents.

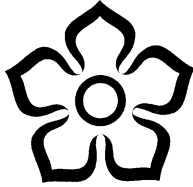
The Court is not persuaded by the argument that there is spare police capacity if the nightclubs nearby are not operating to their maximum or if less than 500 people attend the Candle Rooms. By granting a license the Court would be adding to the number of people within the CIZ and therefore increasing the risks of crime and disorder issues.

The Court has considered the conditions proposed by the appellant at paragraph 26 of his skeleton argument.

In our view these proposals do not address the challenging conditions within the CIZ as a whole but merely the conditions within the premises, car park and its door environs.

The Court has noted the revised application by the appellant regarding licensing hours and activities. However as previously mentioned the Court is not satisfied that these are sufficient to prevent existing problems from being exacerbated. For the sake of completeness the court has considered the car parking issues and whilst the appellant has made arrangements for this the key concern remains the fact that the car parks are within the CIZ adding to its saturation.

The appeal is dismissed.

Summary Update of Penalty Points Scheme

Report of the Director of Neighbourhood and Environmental Services

1. Purpose of Report

- 1.1. To update the Licensing and Public Safety Committee on the council's penalty points scheme

2. Recommendations

- 2.1. Members are asked to note the report.

3. Background

- 3.1. The penalty points scheme relates to licensed drivers of hackney carriages and private hire vehicles. It came into effect on 1st December 2015 on a one year trial basis, and will be reviewed by the City Mayor for determination.
- 3.2. The aim of a penalty points scheme is to provide a consistent approach to dealing with unsatisfactory conduct by licensed drivers, thereby improving driving standards. The scheme acts as a record of a driver's behaviour and conduct to ascertain whether they are a fit and proper person to hold a licence. The scheme does not prejudice the Council's ability to take other action, such as prosecution where this is considered appropriate. If a driver has been given penalty points, it may reduce the duration of the next driver's licence that we issue on renewal.
- 3.3. The current system of enforcement remains unchanged. Any contravention of statutes, rules, regulations and conditions are dealt with in a number of ways, including written notices, written warnings, suspension notices, and prosecution.
- 3.4. The penalty points scheme is separate to the guidelines on convictions, which continues to run in its present form.

- 3.5. The penalty points scheme deals with unsatisfactory conduct. Points may be issued according to the agreed and published tariff. The points tariff is as follows:

	Offence/Breach of Condition	Maximum Points Applicable
1	Providing false or misleading information on licence application form, or failing to provide relevant information.	3
2	Failure to use taxi meter for journeys within prescribed distance	5
3	Refusal to accept hiring without reasonable cause	5
4	Parking a vehicle in contravention of parking restrictions	4
5	Failure to display appropriate plates, or plate improperly secured, or failure to display door signs.	3
6	Failure to wear driver's badge	3
7	Failure to undertake 6 monthly vehicle examination	4
8	Driving a vehicle in an unroadworthy condition (e.g. prohibition notice)	4
9	Failure to notify Licensing Authority of a conviction	3
10	Making of false or misleading statement on licence application form	3
11	Failure to comply with the drivers' code of conduct.	1

- 3.6. Points given to a driver remain on their record for three years from the date they are applied. This was considered to be of sufficient length so as to allow any licensee who may find themselves accumulating penalty points to modify their conduct before facing the possibility of sanctions being taken against them. It is also consistent with the length of time penalty points remain on DVLA licences.
- 3.7. Penalty points are currently issued by the Head of Regulatory Services. Decisions take into account all of the circumstances and are based on documentary evidence, evidence provided by enforcement staff that were present when the infringement took place or written statements from members of the public. Drivers are notified as soon as possible after the alleged conduct took place and are given an opportunity to give an explanation of the circumstances of the allegations being made.
- 3.8. If a driver exceeds 12 penalty points in any three year period, they will be referred to the Licensing Enforcement Sub-Committee, which would consider whether the driver was a fit and proper person to retain their hackney carriage and private hire driver's licence. The Enforcement Sub-Committee would be provided with the information which lead to the imposition of the penalty points and the driver would be given an opportunity to explain why they should still be considered a fit and proper person to hold a licence. Options available to the Committee would include revocation or

suspension of the licence, imposition of additional conditions, such as further training, or to take no action.

- 3.9. The penalty points scheme will be reviewed after 12 months to assess whether it is achieving its objectives, whether it is working fairly, whether the points tariff for each type of offence is reasonable and whether other categories of infringement need to be added.

4 Penalty points issued

- 4.1 In a period of eight months a total of 60 licensees have received penalty points. These are summarised below:

Offence	Number of Licensees issued
Failure to undertake 6 monthly vehicle examination	21
Parking a vehicle in contravention of parking restrictions	31
Driving a vehicle in an unroadworthy condition (eg prohibition notice)	3
Failure to display appropriate plates, or plate improperly secured, or failure to display door signs.	5
