38.	INTRODUCTIONS, APOLOGIES & DECLARATIONS	Councillor Dr Chowdhury, Chair for the meeting, welcomed everyone and led introductions. Apologies for absence were received from Councillor Malik and Darren Evans (City Warden). There were no declarations of interest.
39.	POLICE AND CRIME COMMISSIONER PRESENTATION	<ul> <li>Local Policing Sergeant (Sgt) Nigel Baraclough was present at the meeting and provided the following update:</li> <li>Local Policing Update</li> <li>It was noted that there were issues regarding young males taking drugs and potentially carrying weapons, they were seen to be located around tower blocks in the ward. Several arrests had been made and the Housing department had been informed.</li> <li>Sgt Baraclough gave an update of a gang who were responsible for violent crime in the Ward earlier this year whereby the Police had recovered many assets/ weapons and the gang had now received banning orders preventing them from entering certain areas. Residents were informed that if they knew of any breaches with this group, they could report this on the Police website by typing 'banning order Spinney Hills'.</li> <li>Attendees were also informed that they could attend the monthly meetings held by the Police at Wesley Hall. For dates, it was advised to visit the Leicestershire Police website.</li> </ul>

		<ul> <li>awareness week and informed residents of organisations such as 'Turning Point' which offered a variety of services hubs and 'Dear Albert' which helped individuals stop taking alcohol and drugs.</li> <li>The Police were to follow up on a recent robbery which took place at a relative's house of one of the meetings attendees.</li> </ul>
40.	WARD COMMUNITY BUDGET	Angela Martin – WCEO provided the following update on the Ward Community Budget:
		The opening balance was noted as £18,000.
		The spend to date was $\pounds7,060.66$ and the remaining balance was noted as $\pounds10,939.34$ .
41.	ANY OTHER URGENT BUSINESS	Teaching representatives from Spinney Hill Primary School were present at the meeting and noted the following:
		<ul> <li>Spinney Hills Primary School was proposed as a venue for future Ward meetings.</li> </ul>
		The teachers expressed concerns that the actions which were noted at the last Ward meeting still required looking into, including:
		<ul> <li>Addressing traffic issues outside the school.</li> <li>Three month response from Councillor Malik on how the speed/ traffic/ road blocking/ parking issues surrounding the school were to be resolved had not been received.</li> <li>Further information on the one way system design as it was noted that a Highways Officer had visited the site but nothing further.</li> <li>It was expressed that children's lives were at risk.</li> <li>Teachers requested a crossing patrol.</li> </ul>
		Angela Martin – WCEO would look into how the above actions and those from the previous meeting could be followed up with Councillors and Officers.
