59.	INTRODUCTIONS, APOLOGIES AND DECLARATIONS	Councillor Singh-Johal, Chair for the meeting, welcomed everyone and led introductions. Apologies for absence were received from Councillor Halford. There were no declarations of interest.		
60.	ACTION LOG OF PREVIOUS MEETING	Item 53 – there was clarification that the automatic gates at Janet Setchfield Avenue had not yet been installed, but were in the process of discussion and due to be installed.		
61.	WARD COUNCILLORS' FEEDBACK	Councillor Singh Johal noted that, it had been agreed with Leicester City Council (LCC) that the Sunflowers nursery in Braunstone Leisure Centre would remain in the building and would not lose its space. The proposal to put a gym extension in the centre would not go ahead but could probably happen elsewhere.		
62.	EVESHAM ROAD LINK UPDATE	It was noted that a residents' meeting was previously held at Manor House on 31 January 2018. A written response from Council Officers was circulated at this meeting and is attached at the end of this action log. Grant Butterworth – Head of Planning was present at the meeting and provided information and responded to resident's queries. The following was noted: In regards to the local plan consultation, the government required a long term look ahead regarding plans and developments within the city for the future. The local plan consultation whereby residents could submit their views/ opinions on potential developments and Highways plans across the city (including Evesham Road link) finished in		

- December 2017.
- Officers were currently at the stage of assembling responses from the local plan consultation.
- The next stage would be to produce a report taking into account the responses and present to the City Mayor recommendations on which sites and which infrastructure schemes should be taken forward. Following that a draft Local Plan would be developed, which would be presented for approval at a future Full Council.
- It was noted that this draft plan would be subject of a further round of consultation later in the year before being presented to the government who would then hold an Examination in Public, at which stage people could again give their views.
- There would therefore be further opportunities for residents to make their views known.

Stuart Maxwell – City Transport Director was present at the meeting and confirmed that it was very early days and this stage was to listen to people's views and opinions and look into whether developments would be deliverable, look at the costs involved, positives/ negatives and other impacts.

Residents had a number concerns, many of which were addressed by Grant and Stuart, however most concerns were hypothetical as Officers had already confirmed that there were no definite plans as yet and this stage was to seek public opinion and gather responses.

Residents had the following Highways concerns:

- It was requested for the resurfacing of Evesham Road to be looked into. A resident reported that Somerville Road had grit resurfacing issues such as damaging cars, it was requested that Evesham Road was not resurfaced with the same grit.
- Braunstone Avenue junction near KFC was reported to have pot holes.
- A 20mph zone sign was required on Collingham Road.
- Rat run problems were reported near St Mary's Fields Primary School and Collingham Road.
- The Ward Community Engagement Officer (WCEO) would forward all the above concerns

Potential Future Highway Improvement Scheme - 'Evesham Road Link'

Summary note for Braunstone and Rowley Fields meeting concerning questions raised previously

15th March 2018

Following a number of questions raised previously on this scheme a general note has been prepared together with responses to specific questions where possible.

General note - March 2018

The Council is preparing a new Local Plan to guide future development proposals for the period to 2031. This could identify appropriate highway improvement schemes/lines required to protect land to carry out future transport improvement projects. As part of the recent Emerging Options stage Local Plan consultation process, comments were sought on existing and potential highway improvement schemes/Lines (See https://consultations.leicester.gov.uk/sec/local-plan)

The Emerging Options Local Plan document notes that the existing road network of radial and orbital routes has developed with the growth of the city over time and there remains some gaps in this network that if addressed could potentially improve the efficiency of the network as a whole. The current levels of traffic and congestion on Narborough Road/Upperton Road and at Middleton Street/Aylestone Village highlight the challenges to the road network in this part of the city. The new local plan could identify land required to be protected to construct future schemes to improve the road network.

The longstanding Evesham Road link highway improvement scheme/lines currently identify the land required for a potential future road and bridge connecting Saffron Lane/Aylestone Road and Narborough Road via Boundary Road and edge of Faircharm Industrial Estate/Evesham Road. The improvement scheme/lines are currently declared in local land charge searches for those purchasing land and property that could be affected.

There are currently no detailed road/bridge designs prepared or funding identified to deliver the scheme.

The next stage of the Local Plan is expected to be published later this year and will include draft proposals, including any highway improvement schemes/ lines that the council considers appropriate following further investigation and review. Further public consultation will be carried out at that stage. Subsequently the Local Plan will be considered by an independent Planning Inspector at an Examination in Public.

The proposed highway improvement scheme at Putney Road is a standalone project requiring its own technical justification. It is not dependent on, and would not in itself help to justify the provision of, a future road and bridge link at Evesham Road.

- Q. Will private homes be at risk.
- A. See note regarding road improvement lines
- Q. Will new road be a rat run.
- A. Scheme aim was to relieve congestion on other roads and potentially existing rat runs would require further study/investigation

Currently roads have problems with match day parking.

- Q. Can we Improve public transport, especially park and ride on match days so reduce the need for a new road
- A. Public transport improvements already planned and future schemes will be considered
- Q. Residents feel vulnerable due to speeding. What about speed humps to slow current traffic down.
- A. Programme of 20mph zones and speed humps being delivered across the city
- Q. St Mary's schools have issues about traffic.
- A. Will refer for potential consideration in school run parking improvement programme
- Q. What about the Issue of potential Noise of new traffic.
- A. Would require further study/investigation
- Q. Houses were bought due to the location and its quietness. How will this new road affect residents.
- A. Would require further study/investigation Note above refers to legal searches currently carried out during house purchases
- Q. Residents Cannot see need for another road to relieve congestion.
- A. Would require further study/investigation
- Q. Is this plan being made to relieve upperton road congestion.
- A. Would require further study/investigation
- Q. Aylestone road has congestion problems already. Directing additional traffic there will not improve situation.
- A. Would require further study/investigation

- Q. Can houses be cpo'd
- A. No current plans for CPO. CPO would require further investigation, legal justification and funding in place for the road
- Q. Will residents get full value of house. Residents moved into this area for the quietness and nice environment.
- A. See above answer
- Q. Local plan consultation ended in Nov.
- A. Responses will still be accepted on the Local Plan See note above about next stage of local plan/consultation
- Q. Can we convey that residents are against this project completely.
- A. Through Local Plan consultation see above
- Q. Putney road due to be opened up.how does this impact on link road proposal.
- A. See note above
- Q. Faircharm was not allowed to build houses. Will this new industrial build increase road usage there.
- A. Would require further study/investigation
- Q. Why has Faircharm Been bought.
- A. Not Known
- Q. Can grant Butterworth come to the next ward meeting.
- A. Relevant officers to attend
- Q. Who will benefit from this road, certainly not local residents.
- A. Would require further study/investigation
- Q. Health stats very poor already in our ward.
- A. Scheme would aim to reduce air pollution across the wider highway network
