#### Making meetings accessible to all

<u>Wheelchair access</u> – Public meeting rooms at the City Hall are accessible to wheelchair users. Wheelchair access to City Hall is from the middle entrance door on Charles Street - press the plate on the right hand side of the door to open the door automatically.

<u>Braille/audio tape/translation -</u> If you require this please contact the Democratic Support Officer (production times will depend upon equipment/facility availability).

<u>Induction loops -</u> There are induction loop facilities in City Hall meeting rooms. Please speak to the Democratic Support Officer using the details below.

<u>Filming and Recording the Meeting</u> - The Council is committed to transparency and supports efforts to record and share reports of proceedings of public meetings through a variety of means, including social media. In accordance with government regulations and the Council's policy, persons and press attending any meeting of the Council open to the public (except Licensing Sub Committees and where the public have been formally excluded) are allowed to record and/or report all or part of that meeting. If you intend to film or make an audio recording of a meeting you are asked to notify the relevant Democratic Support Officer in advance of the meeting to ensure that participants can be notified in advance and consideration given to practicalities such as allocating appropriate space in the public gallery etc.

The aim of the Regulations and of the Council's policy is to encourage public interest and engagement so in recording or reporting on proceedings members of the public are asked:

- ✓ to respect the right of others to view and hear debates without interruption;
- ✓ to ensure that the sound on any device is fully muted and intrusive lighting avoided;
- where filming, to only focus on those people actively participating in the meeting;
- ✓ where filming, to (via the Chair of the meeting) ensure that those present are aware that they may be filmed and respect any requests to not be filmed.

### 72. DETERMINATION OF CONTINUED ENTITLEMENT OF A HACKNEY CARRIAGE AND PRIVATE HIRE VEHICLE DRIVER'S LICENCE

The Director of Neighbourhoods and Environmental Services submitted a report concerning the determination of continued entitlement to retain a Hackney Carriage and Private Hire Vehicle Driver's Licence.

The applicant was not present at the meeting. The Licensing Team Manger and Legal Adviser to the Sub-Committee were present at the meeting. The Members of the Sub-Committee agreed to continue with the meeting in the absence of the applicant as they considered the applicant had been given adequate information to attend the meeting, and no communication from the applicant had been received.

The Licensing Team Manager outlined the details of the report, including the relevant City Council Policy Guidelines, and answered questions from Members.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present.

In reaching their decision members felt they should deliberate in private on the basis that this was in the public interest and such outweighed the public interest of their deliberation taking place with parties represented present.

The Legal Adviser to the Sub-Committee and the Licensing Team Manager then withdrew from the meeting.

The Sub-Committee then gave the application full and detailed consideration.

The Legal Adviser to the Sub-Committee and the Licensing Team Manager then returned to the meeting.

**RESOLVED**:

That the applicant's Hackney Carriage and Private Hire Vehicle Driver's Licence be REVOKED.

#### REASON FOR THE DECISION

The Sub-Committee Members had carefully considered the Committee Report placed before them and had taken into account the Council's Driver Penalty Points Scheme, the Regulators' Code and the oral and written representations.

The applicant was asked to appear before the Committee as he had accumulated 12 points under the Council's Driver Penalty Points Scheme in a three-year period. However, the applicant had failed to attend the meeting.

The Sub-Committee Members noted the accumulation only just fell within the three-year period. The earliest points from 2016 had now expired and were no longer on the applicant's record. They also noted that the applicant had been licensed since September 2010 and that Members had not been advised of any other relevant matters in the applicant's record of conduct.

However, the accumulation of 12 points, relating as it did to three separate incidents, was concerning to the Sub-Committee, and they were not satisfied that the applicant had learnt from the interventions of the Licensing Section, and believed that until such time that he did, there was a risk to the public.

In addition, the Sub-Committee had heard that on 06/02/19 the applicant had indicated to a Licensing Officer that he was leaving the trade "as passengers are animals", and that the comment was unacceptable.

In the circumstances the Sub-Committee were of the opinion that the applicant was no longer a fit and proper person to hold a Hackney Carriage & Private Hire Vehicle Driver's Licence, and they accordingly revoked his licence.

The applicant would be advised that he could appeal the decision to the Magistrate's Court.
