# Making meetings accessible to all

<u>Wheelchair access</u> – Public meeting rooms at the City Hall are accessible to wheelchair users. Wheelchair access to City Hall is from the middle entrance door on Charles Street - press the plate on the right hand side of the door to open the door automatically.

<u>Braille/audio tape/translation -</u> If you require this please contact the Democratic Support Officer (production times will depend upon equipment/facility availability).

<u>Induction loops -</u> There are induction loop facilities in City Hall meeting rooms. Please speak to the Democratic Support Officer using the details below.

<u>Filming and Recording the Meeting</u> - The Council is committed to transparency and supports efforts to record and share reports of proceedings of public meetings through a variety of means, including social media. In accordance with government regulations and the Council's policy, persons and press attending any meeting of the Council open to the public (except Licensing Sub Committees and where the public have been formally excluded) are allowed to record and/or report all or part of that meeting. If you intend to film or make an audio recording of a meeting you are asked to notify the relevant Democratic Support Officer in advance of the meeting to ensure that participants can be notified in advance and consideration given to practicalities such as allocating appropriate space in the public gallery etc.

The aim of the Regulations and of the Council's policy is to encourage public interest and engagement so in recording or reporting on proceedings members of the public are asked:

- ✓ to respect the right of others to view and hear debates without interruption;
- ✓ to ensure that the sound on any device is fully muted and intrusive lighting avoided;
- ✓ where filming, to only focus on those people actively participating in the meeting;
- ✓ where filming, to (via the Chair of the meeting) ensure that those present are aware that they may be filmed and respect any requests to not be filmed.

# 6. DETERMINATION OF CONTINUED ENTITLEMENT OF A HACKNEY CARRIAGE AND PRIVATE HIRE VEHICLE DRIVER'S LICENCE

The Director of Neighbourhoods and Environmental Services submitted a report concerning the determination of continued entitlement to retain a Hackney Carriage and Private Hire Vehicle Driver's Licence.

The applicant was present at the meeting accompanied by an advisor. The Licensing Team Manager and Legal Adviser to the Sub-Committee were also present at the meeting. Observing at the meeting were officers of the Council.

Introductions were made, and the Chair outlined the procedure for the meeting to those present.

The Licensing Team Manager outlined the details of the application, in respect of which it was noted that the overriding consideration was the protection of the public and all other matters were secondary to the public safety factor.

Members raised points relating to matters in the report.

The applicant's representative set out the reasons why he ought to be considered a fit and proper person to continue to hold a Hackney Carriage and Private Hire Vehicle Driver's Licence and answered questions from Members.

Members received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those at the meeting.

In reaching their decision, Members felt they should deliberate in private on the

basis that this was in the public interest, and as such outweighed the public interest of their deliberation taking place with the parties represented present.

The Legal Adviser to the Sub-Committee, the Licensing Team Manager, the applicant and his legal representative and observing officers then withdrew from the meeting.

The Sub-Committee gave the application full and detailed consideration.

The Legal Adviser to the Sub-Committee then returned to the meeting to assist Members with the wording of the decision.

The Licensing Team Manager, the applicant and his legal representative and observing officers then returned to the meeting.

The Chair of the Sub-Committee explained to all persons present that they had recalled the Legal Adviser to the Sub-Committee for advice on the wording of the decision.

#### RESOLVED:

That the applicant be allowed to RETAIN his Hackney Carriage and Private Hire Vehicle Driver's Licence.

#### REASON FOR THE DECISION

The Sub-Committee had carefully considered the Committee Report placed before them and had taken into account the Regulators' Code and oral and written representations.

The Sub-Committee were of the view that the issues in the applicant's bankruptcy which had been referred to them were specific to those proceedings and, in this particular case, did not lead them to the conclusion that the applicant was no longer a fit and proper person to hold his licence.

The Sub-Committee were concerned that the Committee was misled on 18<sup>th</sup> January 2019 in that an incorrect answer was given by the applicant's solicitor to a question regarding previous hearings in the applicant's bankruptcy. The Sub-Committee had heard two conflicting accounts as to how and why the incorrect answer was given. The Sub-Committee were not in a position to decide which version was correct, but in any event, this was not necessary.

The Sub-Committee took the provision of incorrect information extremely seriously, but in their view, in the particular circumstance of this case, what transpired on 18<sup>th</sup> January 2019 did not lead the Sub-Committee to the conclusion that the applicant was no longer a fit and proper person to hold his licence.

The Sub-Committee were advised that in the many years the applicant had held his licence, the Licensing Authority had received no complaints regarding his conduct from taxi passengers, other taxi drivers or road users whilst

working as a taxi driver and no points had been recorded on his licence under the Council's Penalty Points Scheme.

In those circumstances the Sub-Committee were of the opinion that the applicant continued to be a fit and proper person to hold a Hackney Carriage and Private Hire Vehicle Driver's Licence and that their decision was to allow the applicant to retain his licence.
