1. Summary

This report is seeking approval for:-

 Delivery of the Growth Hub project funded by the European Regional Development Fund (ERDF) which will support businesses in Leicester and Leicestershire to access business support, including events, workshops, capital business grants and one to one support for businesses.

2. Recommendations

That the City Mayor:

2.1 Accept the ERDF funding (£3.9m) and agree for the city council to act as accountable body in relation to it;

2.2 Add £1.4m to the capital programme, in respect of SME grants; and

2.3 Approve a City Council match funding contribution of £516k from existing budget resources.

2.4 Delegate to the Director of Tourism, Culture & Inward Investment in consultation with the Director of Finance the authority to distribute and allocate the ERDF funding to further the aims of the project subject to the terms of any agreements required in consultation with Legal Services.

3. Supporting information including options considered:

An application was made for European Regional Development Funding (ERDF) for the development of a business support, business grant, investor readiness, scale-up and property support scheme in April 2018. The project has been approved and a contract received.

The total project cost is £7.9m, the table below provide details of the contributions from each match funding partner.

The project proposal has been led by Leicester City Council, and developed as a partnership with Leicestershire County Council, the East Midlands Chamber and the Leicester and Leicestershire Enterprise Partnership (LLEP), building on existing joint working.

The project runs from 1st January 2019 to 31st December 2021.

Leicestershire Growth Hub covers the whole of the Local Enterprise Partnership area and will support 536 SMEs and create 212 new jobs through the following key activities:

- A core information service: a dedicated marketing and first point of call and referral service for business support (virtual, phone line and physical);
- A localised SME intensive support programme (IDB Business Advice, access to a wider network of business support providers);
- Access to finance through a dedicated grant scheme offering 35% funding for growth businesses, access to complementary schemes such as the Digital Growth Programme
- LEP-wide: business related events, strategic workshops and an annual Business Conference;
- Enhanced business support including a dedicated Scale Up Programme; Investor Readiness Programme and Property support service.

The City Council is experienced in delivering and managing business support grant programmes including the successful Enterprising Leicester, Collaborate (ERDF funded) and Enterprising Leicestershire schemes (RGF funded) which operated throughout 2014, 2015 and Collaborate scheme finishing in Sept 2019. These schemes supported around 270 businesses and created more than 600 jobs at an average cost of £5,600 per job. The new capital grant scheme is anticipated to support around 86 businesses and deliver 212 jobs

5. Financial, legal and other implications

5.1 Financial implications

The report proposes approval to accept £3.9m of ERDF funding and to act as accountable body. The City Council's match funding contribution is from existing resources, notably staff time. The SME grants of £1.4m will be capital spending, and hence should be added to the capital programme.

5.2 Legal implications

The conditions of the ERDF funding will need to be reviewed by legal though given these are Central Funds these are likely to be non-negotiable in any case.

The use of the funding and any grant awards of the funding to third parties will need to reflect the requirements on the Council (and step-down obligations where appropriate) under the ERDF funding terms. In addition, State Aid will need to be considered.

The Leicestershire Growth Hub Project should be underpinned by a partnering agreement to secure the respective rights and obligations of the partners as soon as possible.
