Dear objector 1

I appreciate that you are concerned at the width of Ariane Place outside your home.

I have spoken to the officer responsible for developments across the City and he has confirmed that the layout of the road cannot be changed.

You do not want to park wholly on the carriageway as this may risk your vehicle being damaged by large vehicles passing and that parking partly on the footway will obstruct pedestrians and you don't see why you should pay for a permit when you are uncomfortable parking on such a narrow road. Unfortunately, changing the carriageway width is not possible, although we are still willing to provide a single yellow line waiting restriction on the south side of Ariane Place to ensure no vehicles can park directly outside your home during the daytime, (in addition to the no waiting at any time restrictions already proposed on the north side of Ariane Place) but this will have to be introduced as part of a further Traffic Regulation Order (TRO).

At the meeting that was held with residents of Ariane Close, Beagle Close and Discovery Road there was a consensus that a resident' only parking scheme operating between Monday and Friday from 9am and 4pm was the most appropriate solution to take into consideration as many people's requirements as possible.

The proposals are aimed at stopping commuters and other visitors parking on the estate once no waiting at any time parking restrictions are introduced on Exploration Drive and outside of the proposed times for the residents' parking scheme, any vehicles will be able to park on Ariane Place, Beagle Close and Discovery Road.

I note also that you do have a garage and drive-way that should be sufficient to keep two vehicles off the highway.

In light of the above please can you confirm if you will withdraw your objection, otherwise, your objection will be submitted for consideration by the City Council's Planning and Development Control Committee. Provisionally at the meeting scheduled for 11th December 2019 which will take place in Meeting Rooms G.01 and G.02, Ground Floor, City Hall, 115 Charles Street, Leicester, LE1 1FZ. The meeting begins at 5.30pm.

As I said, the permit scheme idea will work on discovery Rd but it does not serve the purpose on the short and narrow stretch of the road on Ariane place. If a scheme is implemented then it needs to be function-able and serve its purpose. A parking permit paid to park outside my house does definitely not serve the purpose of residential parking scheme in its present state of the road.

This road, if widened then I have no problem because permit scheme would then serve its purpose and I can comfortably park my car without any worries. My permit payment would then be worth investing in.

Chris- I can ensure you that I am not having a go at you. Only single yellow on our side and not residential permit. Double yellow on the other side as suggested would all suffice. Thanks again.
