Safer Leicester Partnership

The 1998 Crime and Disorder Act established **partnerships** between local authorities, the police & police authorities, fire service, probation service, health authorities, the voluntary sector, and local residents and businesses.

The groups are known as the **Community Safety Partnerships**.

SLP VISION 2018 - 2021

To ensure that all citizens of Leicester feel safe within their communities and benefit from an improved quality of life and well-being through partnership working to reduce crime, disorder and vulnerability.

SLP PRIORITIES 2018 – 2021

- To reduce serious violent crime associated with knife crime and the night time economy
- To support the Prevent agenda and deter extremism
- To reduce the impact of begging, substance misuse and Anti-Social Behaviour associated with Street Lifestyles
- To encourage reporting and to reduce repeat incidents of domestic and sexual abuse
- To communicate new and emerging threats and how residents can reduce the likelihood of becoming victims of crime
- To work with partners to identify vulnerability and safeguarding issues to reduce adult sexual exploitation and serious & organised crime

Need for an annual Refresh.....

- Test priorities still relevant
- Priorities no longer needed
- New areas need to be considered
- More or less work needed against each priority

SLP PRIORITIES 2019 - 2020

- To reduce serious violent crime associated with knife crime and the night time economy
 - Work with young people and schools
 - Production of knife crime strategy
 - Purple Flag Submission
- To support the Prevent agenda and deter extremism including **hate crime/ incidents.**
 - Range of workshops funded by the HO to safeguard individuals from becoming radicalised.

SLP PRIORITIES 2019 – 2020 Cont..

- To reduce the impact of begging, substance misuse and Anti-Social Behaviour associated with Street Lifestyles
 - Worked with 121 individuals who have street lifestyle issues.
 - Have put in supportive measures, now exploring increased enforcement approach
- To encourage reporting and to reduce repeat incidents of domestic and sexual abuse
 - Supporting victims of DASV
 - Commissioning of future services
 - Conducting domestic homicide reviews (to learn lessons)

SLP PRIORITIES 2019 – 2020 Cont..

- To communicate new and emerging threats...
 - Community safety campaigns e.g. celebrate safely
- To work with partners to identify vulnerability and safeguarding issues in to reduce such as (sexual exploitation, **modern-day slavery, county lines** and serious & organised crime)
 - Engaged in police operation to help break county lines operation
 - Working on a pilot around MDS and the garment sector.
