### APPLICATION FOR THE GRANT OF A HIGHWAYS AMENITIES LICENCE (STREET CAFÉ) OASIS LOUNGE (MELAYA LTD) 13 NARBOROUGH ROAD, LEICESTER. LE3 0EL

### Report of the Director (Neighbourhood & Environmental Services)

### 1. Purpose of the Report

To determine an application for the grant of a Highways Amenities Licence for a Street Café for premises to be known as Oasis Lounge (Melaya Ltd) 13 Narborough Road Leicester LE3 0EL. The applicant is a Miss Narcis BARI.

### 2. Options for the Sub-Committee

The Sub-Committee may determine the application in one of the following ways: -

### (1) Grant

The Sub-Committee may grant the application.

If the Sub-Committee decide to grant the application, it should be subject to the standard conditions applicable to Highway Amenities Licences.

### (2) Grant subject to special conditions

The Sub-Committee may grant the application subject to such variations, conditions or restrictions, as they think fit.

### (3) Refuse

The Sub-Committee may refuse the application.

In arriving at its decision, the Sub-Committee should consider the comments put forward by the applicant and any other information provided in the report.

The Sub-Committee must give the applicant the reasons for the decision it makes when it is announced.

### 4. Report

On Wednesday 12<sup>th</sup> February 2020 an application was submitted by Miss Narcis BARI, proprietor of Oasis Lounge (Melaya Ltd) for the grant of a Highway Amenities Licence (Street Café).

The premises are situated within a row of shops and businesses on Narborough Road near to its junction with Hinckley Road/Braunstone Gate. There is a wide range of businesses in this area including office premises, retail premises, restaurants, take away food outlets and car sales. There are a number of residential apartment and flat type premises generally situated above the retail premises. Due to the range of retail, fast food and residential premises the area is busy at all times of the day.

In past years, the site was previously a bar by a similar name and the current applicant has taken over the running and has made improvements to the premises in order to change the type of clientele.

The applicant submitted an original plan which detailed **two tables and four chairs**, to be placed in front of the premises to the right of the front door as viewed from the pavement.

The tables and chairs are to be contained within the requested area, sectioned off by barriers.

The furniture and barriers proposed are in line with Authorised Street Café furniture.

The applicant initially requested to use the street café between the following hours:

```
10:00hrs – 02:00hrs on Monday to Saturday 10:00hrs – 01:30hrs on Sunday
```

After early consultation with the Licensing Authority these times were revised and the applicant now requests:

### 10:00hrs – 22:00hrs on Monday to Sunday

On 27<sup>th</sup> May 2020, 31 letters of consultation were hand delivered to surrounding businesses and residential premises within the area to advise them of the application and a public notice was prominently displayed on the premises itself. This was checked to ensure it remained in situ throughout the consultation period.

Any objections were to be received no later than 28 days from the date of the notice.

Consultations were also carried out with Councillors who represent the **Westcotes Ward** of the City, Leicestershire Police, Leicestershire Fire & Rescue Service, Noise Pollution, Planning, Public Safety and Highway/Traffic Management.

There was a concern raised from Leicester City Council Highways in respect of the initial layout and its proximity to street furniture. However, the applicant has worked with the authority and has reduced the café size from **1.5M to 1.2M** to comply with the request. This objection has therefore been formally withdrawn.

Within the representation period, there were a total of three objections, all from local businesses in the area.

All objections were accepted as being 'relevant' to the application. The objections raise concerns about Crime and Anti-Social Behaviour, Drinking, Smoking, Littering, Parking and Noise. All objections are attached to this report and detailed in the appendix list below.

The response received from the applicant is also attached to this report which seeks to address the objector's concerns.

### 5. Policy Guidelines

The overall policy on Street Cafes is to encourage more restaurants, cafes and public houses to have more outside activity in the street which would give an ambience that makes the City more attractive to visitors and residents alike. If an objection is received, the Sub-Committee should consider the impact a street café may have on residents and any surrounding businesses in the area.

### 6. Legal Implications (including Human Rights Act)

A licensing decision is also a determination of civil rights to which Article 6 the right to a fair trial applies. Article 8 the right to respect for private and family life applies to the protection on neighbouring properties from noise and disturbance. Article 1 of the First Protocol gives the right of peaceful enjoyment of possessions, which would include a licence. Terms and conditions imposed on the grant of a licence will need to be proportionate, and necessary to protect the interests of a democratic society.

There is no right of appeal against the refusal to grant a Highway Amenities Licence.







Good afternoon Matthew,

As you have inspected earlier in the year, you have been able to see that we are taking a very close approach towards the cleanliness within the premises and around it.

We have in place regular cleaning schedules and to maintain a cleaner environment around our location we have installed an outdoor ashtray at the entrance available for customers, but also for members of the public.

Furthermore we make sure to brush and collect any rubbish in front of our cafe at least twice a day (open and closing time) and whenever necessary throughout our operating times. We also care for the safety of our community and our staff, for that we have recording cctv circuit indoors and outdoors, a no tolerance rule towards any abusive, insulting or dangerous behaviour, there are also signs displayed within the premises reinforcing this matter and we refuse to serve customers who already shows signs of drunkenness.

For any incidents that we cannot control we work closely with Police Community Officers, to intervene if case might be. We pride ourselves for being a place of relaxation and bonne-Heure, a cultural social club where customers can have a drink, relax and have meaningful conversations (our Customer reviews can emphasise that), therefore the lounge music we play is at a low level and is controllable easily by the staff, we have never had any complaints from the neighbours around or above the premises.

The main reason for having this cafe licence in place is actually to have a Safe delimitation between our smoking customers and passers-by and also an assigned outdoor space for disabled customers who doesn't wish to stay indoors and the customers who come accompanied by pets.

I truly believe that having this licence agreed, it will allow us to better manage the environment around our business and to satisfy the customer's needs (who are actually part of the community we serve).
