REFERRAL TO THE COMMITTEE BY THE UNIVERSITY HOSPITALS LEICESTER PUBLIC AND PATIENT INVOLVEMENT FORUM

1. PURPOSE OF REPORT

This report informs the Committee of a recent referral to the Joint Committee of the above matter by the University Hospitals Leicester (UHL) Patient and Public Involvement Forum (PPIF).

3. OPTIONS

Legal advice is being sought in respect of the Committee's powers in relation to this referral. The options available to the Committee will be advised at the meeting.

4. REPORT

The Committee will be aware of the circumstances leading to this referral. The former UHL Chief Executive, Dr Peter Reading, retired on 21 September 2007. Dr Reading's retirement was agreed between himself and the UHL Trust, and, as is normal practice for individual staffing matters, details of this agreement remain confidential. Dr Reading

did not work a notice period. On 28 September 2007, UHL announced the appointment of Derek Smith as interim Chief Executive, to take up his post on 1 October 2007, for a three month period.

Between October and December 2007, there was significant local media coverage regarding both Dr Reading's departure and Mr Smith's appointment – in the case of the former primarily around the decision-making surrounding his departure, and in the case of the latter, the cost of the interim arrangements.

The UHL Patient and Public Involvement Forum have long expressed their concern about the Trust's handling of the matter. In December 2007, the PPIF passed a resolution referring the matter to the Audit Commission. The attached correspondence shows the detail of that referral and the Trust Auditor's response.

In its letter to the Committee dated 10 March 2008, the PPIF invites the Committee "to require the Auditor to release the evidence gathered and justify his opinion that the very large sum so far expended in this connection from the public purse represented proper value for money".

A supplementary paper will be circulated before the meeting; it is anticipated that this will

- Provide some context on the respective roles of, and relationships between, the PPIF, the Committee, and the Audit Commission;
- Offer the Committee guidance on its powers in respect of the request from the PPIF
- Set out options for action in responding to the referral.
