We are the main provider of specialist community services, inpatient care and outpatient clinics to help the one in four of us who will experience mental health difficulties at some point during our lives. We also provide services for people with a learning disability and their families. Our services are:

- Mental health services for children and young people.
- Inpatient and community mental health services for adults of all ages.
- Services for adults with a learning disability.
- Substance misuse services; drugs and alcohol.
- Other specialist services, for example forensic services and eating disorder services.

## • Did you know...?

- We serve a large and varied population of 924,000.
- Over 37,000 referrals are made to LPT services each year.
- We provide services from over 100 locations across Leicester, Leicestershire and Rutland—as well as in people's own homes.
- We are one of the largest local employers, with around 3000 staff Over 2700 of them provide direct clinical care.
- We have an annual income of £137 million.

# All NHS Trusts now have the opportunity to become a Foundation Trust. We hope to become one by July 2009.

As a NHS Foundation Trust we will continue to provide healthcare services, free at the point of delivery – as we do now. We will remain part of the NHS, working to the same national standards as all other NHS service providers.

There are ways that we will be different as a NHS Foundation Trust, as follows:

- We will be accountable to local people for the way services are provided rather than to central government. The main way we will be accountable to local people and involve them in decisions is through a membership system that is free to join and open to people living in Leicester, Leicestershire and Rutland.
- We will be able to involve local people and staff more directly in decisions about the way services are planned and delivered.

- We will have greater freedom to decide how services should be provided locally.
- We will have new financial freedoms, such as being able to keep any surplus money we make or gain from the sale of property. We can use this money for investment in new services. Along with the new freedoms there are some risks because we will be responsible for our own finances.
- We will be regulated by Monitor (the Independent Regulator of NHS Foundation Trusts) - Monitor will make sure we manage our finances properly, are well governed and continue to provide an agreed range of core services.

We are very supportive and thankful for the help that our many volunteers provide to our patients and services and hold events to celebrate their contributions.

We want to become a NHS Foundation Trust because the time is right for us.

We're prepared for it, we're enthusiastic about connecting much more closely with local people and communities and we're eager to take every opportunity available to improve services.

We strongly recommend NHS Foundation Trust status because it will bring these extra benefits for local services:

## • Local ownership.

Local people will have strong influence and a real say on how services are delivered and planned.

### • Connecting with diverse communities.

We already have successful partnerships with many individuals, communities and organisations, but we can increase these opportunities and work together in new and more creative ways.

## • Financial stability

We will have much greater local control over how we spend our money and invest in new developments.

### Innovation and service improvements.

We have set out a clear vision—our 2012 Vision—of what we want to achieve over the next five years to improve services. The financial freedoms that come with being a Foundation Trust mean we can plan better for the future, set our own pace for new schemes and target investment or borrow money so they can happen more quickly.

## • Support for social inclusion.

People who use our services sometimes find it hard to take advantage of job opportunities, education, housing and leisure activities. Through the improved local connections that Foundation Trust status brings we will be able to offer more support for people using our services.

### Attracting and keeping high quality staff.

Staff will have more say in running the Foundation Trust and our ability to progress new developments will attract and keep skilled staff.

# Our plans: Our 2012 Vision.

Our 2012 Vision, describes how LPT will work to lead and champion year-on-year improvements in wellbeing for the communities we serve in Leicester, Leicestershire, Rutland and beyond.

- We will deliver improved wellbeing by meeting people's needs as close to home as possible, by providing integrated care that considers all the needs a person might have, and by working more closely with local communities and partners.
- We will offer excellence and best practice in all that we do. For example, we plan to introduce community services that are focussed on the needs of specific localities and are better integrated with other local services and organisations. We also want to redesign our inpatient services and bring some services together on single sites where we can create centres of excellence.
- We will have a business-like approach to using public money wisely, working efficiently and being open and clear about what we are doing. For example, we will review our corporate services, improve staff development opportunities and do more research to understand the needs of local people and the best ways of meeting those needs.
- We will be aware of the environment in which we operate, with our organisation playing its role as a 'citizen' in local communities. For example, we will get involved in community activities and review our plans regularly to make sure they continue to meet the needs of the changing local population.

We are committed to three aims as a NHS Foundation Trust, which are:

- To provide the highest quality services possible.
- To operate in a business-like, wellgoverned and efficient manner.
- To be an open public organisation that explains itself clearly and works for the benefit of local people.

Across all these aims we will put our engagement with communities, the protection of human rights and the promotion of inclusion at the heart of all that we do. We shall work with the University of Central Lancashire to establish CORIIN, the Centre for Communities, Rights and Inclusion, to advise on our practice and renew our partnerships.

# How our NHS Foundation Trust would be run.

The way that Leicestershire Partnership NHS Trust is governed will change if we become a NHS Foundation Trust.

A new governing structure will be created that allows people who use our services, carers, people living in Leicester, Leicestershire and Rutland and our staff more say over what we do and how we do it. The new structure has three main parts.

## 1 Membership.

Members of the public, service users, carers and staff can join as members of the NHS Foundation Trust. We are proposing that the lowest age someone can become a member should be 14 years. We are also recommending that there are six membership categories and these are:

- Members of the public resident in Leicestershire County.
- Members of the public resident in Rutland County.
- Members of the public resident in Leicester City.
- Users of the Trust's services.
- Carers of people using the Trust's services.
- Trust staff.

A further option we are considering is to widen the scope of participation to include members from outside our counties, to bring a different perspective. If they wish, members can put themselves forward for election as a Governor to be on the Council of Governors. They are elected by the other members in their membership category.

We are keen to have representation for people with a learning disability and younger service users, and would like to know if you agree that these groups should be represented on the Council as service user Governors.

## 2 A Council of Governors.

The Council of Governors will work closely with the Board of Directors. Its responsibilities include representing the views of members and local communities to the Board of Directors, providing advice and examining long-term plans and making sure that LPT operates in line with its terms of authorisation as a NHS Foundation Trust.

We are recommending that the lowest age someone can become a Governor should be 16 years. The table above shows who we suggest should be on the Council of Governors. The total number of Governors is 29. This should provide a manageable size that will allow good discussion to take place at meetings and at the same time makes it possible to have good representation from the various membership categories.

#### 3 A Board of Directors.

The day-to-day planning and management of services will still be carried out by the Board of Directors. The Board of Directors will work with the Council of Governors and take the Governors' views into account when agreeing the long-term plans of the Trust. The Board of Directors would be made up of Executive and Non-Executive Directors, in much the same way as the current Trust Board. The Chairman of the Trust would Chair both the Board of Directors and the Council of Governors.
