| | Sub-targets to be set for Council travel, street lighting and signage/traffic signals during 2009/10. | In relation to Council travel, an independent Green Fleet Review undertaken for the Council in 2007 identified significant potential for the Council to reduce the environmental impact of its travel. It suggested a target to "Reduce 'Grey Fleet' mileage by 5% P/A ongoing until end 2011/12" and recommended the continued modernisation of the Council Fleet and the roll-out of 'driver awareness' training, which has been shown to achieve more than a 10% reduction in emissions for some drivers. Other local authorities are known to have set themselves targets for reducing business travel impact. These include Portsmouth City Council (10% emissions reduction by 2009/10), Derby City Council (6%), Staffordshire and St Edmundsbury. Action by these authorities to meet their targets varies from compulsory driver awareness sessions for pool car users to the introduction of electric vehicles or incar monitoring equipment to measure driver fuel-efficiency and safety. Whilst these actions do require investment, they can potentially bring savings in reduced insurance premiums and accidents as well as fuel bills. The full, long-term potential for the Council to reduce its travel fuel use is not yet known and it is proposed to investigate this during 2009/10 by working closely with a cross-section of Council services – with the aim of setting a long-term target by the end of 2009/10. In the meantime, action at a service level will be promoted through a Council-wide campaign modelled on the success of the recent "Big Switch Off" and rolled out by the Environment Network – challenging each service to identify fuel savings. Complementing measures taken within each service, existing measures within the Internal Travel Plan to promote cycling, bus use and car sharing should help by shifting the culture away from single occupancy car travel as the first choice for journeys. The level of performance proposed in the target (17.2) is based on many years of experience in the Council specifying recycled paper products appropriate to user requirements. Based on this experience, less stringent minimum standards are being proposed for two categories: 'publications, leaflets, flyers and posters' and printing of 'web products' where client requirements or product availability may sometimes preclude the use of recycled paper with a 100% post consumer waste content. Officers are confident that these standards are achievable. We will look to ensure that a statement of recycled content is included on all publications – to demonstrate what the Council is doing on this issue. In relation to digital colour low volume printing, the standard proposed relates only to 'basic' printing. Creativity Works is currently testing recycled paper options for use in high quality digital colour printing. Hence, a standard for this category is not currently being proposed.
