This is a premises licence and pavement licence review application for Rum & Spice, 2 King Street Leicester. LE1 6RH. The venue was formally known as That's Amore.

Leicester City Council Premises Licence number LEIPRM0791 and Leicester City Council Payement Licence number LEISC5746.

Rum & Spice Limited (Companies House number 15101631) was incorporated in August 2023 and Mr Merenre Millett was appointed as the sole director of the company.

The premises licence was initially granted in 2009 but was transferred to Mr Millett in November 2023.

Between November 2023 and April 2024, the premises underwent a major refurbishment with the grand opening being advertised as the 4<sup>th</sup> May 2024.

Despite a major refurbishment, no minor variation has been received for the significant alterations to the ground floor and the inclusion of the basement area. Whilst the first, second and third floors are now residential flats.

The licence was until 15<sup>th</sup> October 2024, still in the premises previous name of "That's Amore".

In March 2024, a new designated premises supervisor (DPS) was appointed. I will refer to this person as "person A". In June and July 2024, several DPS transfer applications were submitted but all rejected due to administrative errors.

On the 2<sup>nd</sup> October 2024, an officer from Leicestershire Police contacted the venues alleged designated premises supervisor (DPS), thus person A in relation to assessing the venues CCTV system. This was in light of a criminal investigation connected to the venue. Person A informed the officer that he was no longer involved in the business and had not been so since July/August 2024. The officer attempted to contact Mr Millett but received no response.

On the 9<sup>th</sup> October 2024, PC Pritchard from Leicestershire Police also contacted person A. Person A, again confirmed he had left the business in July 2024, was no longer involved in the business in any capacity and was not in day-to-day control of the business as defined by the legal definition of a DPS as per the Licensing Act 2003. Person A stated he had twice withdrawn his consent in writing and was unsure why he was still showing as being the venues DPS.

On the 20<sup>th</sup> September 2024, a new DPS transfer application was submitted. However, the form was not signed and was not signed by Mr Millett and Mr Niblett until the 10<sup>th</sup> October, when a meeting was held with the police and council. During the meeting, Mr Niblett stated he was not physically going to start at the premises until Saturday 26<sup>th</sup> October 2024, due to existing work and holiday commitments.

Therefore, Leicestershire Police would argue that Mr Niblett has not been fulfilling his legal responsibilities as DPS, as defined by the Licensing Act 2003 as he has not yet physically started at the venue.

Leicestershire Police would also state that the venue has been operating illegally as it has been trading and providing licensable activities including the sale of alcohol without an "active" DPS between the end of July/start of August 2024 and the 20<sup>th</sup> September 2024.

The premises operates as restaurant and bar. However, the premises primary activity is as a late night, alcohol led, stand up bar as the venue regularly does not open until 11pm.

The premises opening hours to the public are: Monday to Thursday from 11am until 3am. Friday & Saturday from 11am until 6am. Sunday from 12 noon until 3am.

However, the premises has a specific licence condition under Annex 2 of the licence which states, "The licence holder will ensure no entry to the premises is allowed by customers after 4am".

The premises is suspected to have been in breach of this condition and operating after 6am on both Saturday 14<sup>th</sup> and Sunday 15<sup>th</sup> September 2024.

At 4:10am on Saturday 28<sup>th</sup> September 2024, an officer from Leicestershire Police observed customers still entering the premises. On challenging door staff, they stated they were unaware of this condition preventing entry after 4am. The officer proceeded to speak to a person who he described as being confrontational who also stated words to the effect of "It wasn't a problem last week or the week before".

At 4:25am on Sunday 20<sup>th</sup> October 2024, a third-party security provider at the venue approached police officers stood nearby. The security provider stated his team was withdrawing from the venue due to public safety concerns as they could not guarantee customers safety, as the venues management and promotor had been allowing customers into the venue without being searched and was knowingly breaching its licence conditions but still allowing new customers into the venue after 4am.

As a result of the security team withdrawing from the venue, the police elected to close the venue early due to concerns about public safety.

In May 2024, the premises was granted a Leicester City Council Pavement Licence. (LEISC5746). The licence is also in the name of Mr Merenre Millett. The pavement licence permits the venue to place street furniture on the public highway, daily between 11am and 11pm. The pavement licence was granted on the 7<sup>th</sup> May 2024 and expiries on the 6<sup>th</sup> May 2026. The pavement licence is subject to standard conditions set by the council and describes in detail what is classified as a licenced area and what is pavement licence furniture.

In simple terms, all the venues pavement licence furniture has to be removed from the public highway between the hours of 11pm and 11am.

Since the 15<sup>th</sup> September 2024, the premises has breached its Leicester City Council Pavement licence conditions on at least ten occasions. Those being:

- (1) Sunday 15<sup>th</sup> September 2024 @ 7:15am
- (2) Monday 30<sup>th</sup> September 2024 @ approximately 7:20am.
- (3) Tuesday 1st October 2024 @ approximately 7am.
- (4) Friday 11<sup>th</sup> October 2024 @ 7:20am.
- (5) Saturday 12th October 2024 @ 9am.
- (6) Thursday 17<sup>th</sup> October 2024 @ 7:15am.
- (7) Friday 18<sup>th</sup> October 2024 @ 7:20am.
- (8) Saturday 19th October 2024 @ 9:20am.
- (9) Sunday 20<sup>th</sup> October 2024 @ 4:30am.
- (10) Monday 21st October 2024 @ 8:15am.

On Friday 20<sup>th</sup> September 2024, Leicestershire Police and Leicester City Council Licensing Enforcement Officers visited the premises. PC Pritchard spoke with Mr Millett on the telephone as he was not present and outlined the reason for the visit. Mr Millett was informed that a letter from the police would be left at the venue for his immediate attention. The letter raised serious concerns about the venue and invited Mr Millett to attend a meeting to discuss these concerns further in person.

Despite the above request, a meeting was not held until Thursday 10<sup>th</sup> October 2024. Both Mr Millett and the newly appointed designated premises supervisor attended, as well as a representative from Leicester City Council Licensing Enforcement. Mr Millett was again given a verbal warning by the police and council about the use of the pavement licence furniture on the public highway between 11pm and 11am. PC Pritchard stressed why it was important to adhere to this condition from a crime prevention and public safety aspect.

Despite this meeting, the pavement licence furniture remained on the public highway the following morning. On Friday 11<sup>th</sup> October 2024, PC Pritchard emailed Mr Millett a summary of yesterday's meetings and re-iterated the police's previous concerns/warnings.

On Friday 18<sup>th</sup> October 2024, Mr Millett was sent a further written warning about breaches of the pavement licence conditions. Mr Millett did not acknowledge this email, however that afternoon a person who had previously identified themselves as a general manager at the venue called PC Pritchard and asked for clarification.

Again, the general manager was instructed to adhere to all conditions of their Leicester City Council Premises Licence and pavement licence.
Despite events of Friday 18 <sup>th</sup> October, further breaches occurred on a further three consecutive days over the weekend.
Therefore, Leicestershire Police requests a review of Rum & Spice's premises licence and pavement licence, as the premises is failing to promote all four licensing objectives and is putting customers at the risk of harm.
