Please summarise your concerns about this application:
<p>I write in my capacity as licensing officer for Leicestershire Police, on the authority delegated to me by the Chief Constable.</p> <p>My representation to this temporary event notice is based upon two of the licensing objectives, as per the Licensing Act 2003. Namely, public safety and the protection of children from harm.</p>

The event is scheduled for Sunday 18th May 2025 between 1pm and 9pm.

The event is described as a boxing event for participants between the ages of 10-35 years.

The event is scheduled to take place within an existing licensed premises - Leicester City Council Premises Licence number LEIPRM1920.

Boxing is a high-risk sport in which participants can be seriously injured. In the last few years, there have been several high-profile fatalities reported in the press.

The application does not specify what medical provision will be provided and what safety measures will be implemented on the day in order to protect participants. More so, given some of the participants will be children.

Alcohol will be on sale at the time of the event which can alter crowd dynamics and behaviours and is detrimental to the protection of children from harm. Alcohol will also be on sale at an event where some of spectators are also under the age of 18 years, however there is no mention of a Challenge Policy in the application.

Given the type of the event, Leicestershire Police would have expected an event risk assessment to have been submitted along with the temporary event notice. And/or additional information to include details of the participants, relevant medical provision, insurance policies and relevant boxing rules/accreditation.

On Friday 28th March 2025, the applicant submitted an almost identical application for the same event.

On Tuesday 1st April 2025, Leicestershire Police submitted a representation. A hearing was set for 8th April, however the applicant withdrew the application on the 4th April.

PC Pritchard from Leicestershire Police emailed the applicant on the 29th March and 1st April (as well as the original representation) detailing what was required in order to satisfy the police and give confidence the risk event would be managed safely.

A risk assessment was not originally submitted with this application but has now been provided. The applicant has submitted some further information with an overview of the boxing academy but as yet has not provided details of the participants, medical provision details, copies of insurances policies, official accreditation documentation detailing the rules and safeguarding measures, more so given that some of the participants are children.

Until these have been received and evaluated, Leicestershire Police are unable to fully assess the event.

Due to the above reasons, Leicestershire Police respectfully requests this temporary event notice is refused, as it fails to promote two of four licensing objectives, namely:

- (1) Public safety
- (2) The protection of children from harm.
