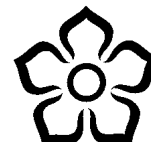

## Appendix 1 - Housing Update



### Environmental Improvements 2024-25

In 2024-25 after a consultation process with the residents at 22-52 Kingfisher Avenue we:

- 1) Successfully remove the shrubs between the flats and Humberstone Road, close to the Merlyn Vaz Centre. The shrubs were untidy and harbouring rodents.

- 2) Finally, to provide a defendable space we also placed an eco-wood fence between the garden of the flats and the road verge.



- 3) We are also this week introducing a residents parking scheme to the car park for these flats as they constantly suffer from visitors to the Merlyn Vaz Centre taking their parking spaces.

### **Environmental Improvements 2025-26**

We welcome any suggestions for improvements to housing land in North Evington, the main areas being Lombardy Rise/Oak Street flats, Chamwood Estate, and Beatty Avenue. Residents are able to purchase an annual permit which costs £10.

We are considering a further Residents Parking scheme on the Chamwood estate. Any scheme would need to consider:

- Restricted to only parking spaces on Housing land
- Most of the parking on Chamwood estate is on street, on the Highway, which Housing has no jurisdiction over.
- Subject to a consultation of ALL residents on the estate

The plan below shows the location of housing owned parking bays on Charnwood estate:



They are comprised of a few small parking bays on:

- Charnwood Walk, Dunlin Road, Sandpiper Close, Famham Street, Helena Roberts House.

Some of these locations may require the bays being marked out clearly

With an option to also include the garages forecourts to prevent cars parking in front of the garages blocking access. In which case we would also need to consult the licensees and owners of the garages.

It is unclear how effective a Residents Parking scheme would be on Charnwood estate, with it being restricted to a few parking bays.

## **Appendix 2 – City Warden Update**

Fly-tipping on bridge road has been monitored and investigated with a number of interviews for fly-tipping (5)

Some are still being investigated and resolved cases have been issued with fixed penalty notices have been issued.

Signs were placed around the streets for fly-tipping.

Cottesmore road cars for sale - we have monitored and issued a number of fixed penalty notices (6), and this seemed to have solved the issue.

We have not received any new reports.

With regards to cars for sale there is a strict process we must follow, and the following information is required:

1. Registration numbers, make and model of the vehicles and photo.
2. Where the cars are being sold online providing screen shots of them is a must.
3. Any for sale signs in the vehicle's photographs taken.

Without this information there cannot be any investigation the warden will contact the complainant and will also advise on a personal basis.

Side streets are still heavily fly-tipped and due to us monitoring the site and actioning where evidence had been identified, information letters have also been sent to residents.

Nottingham road is an ongoing project and every residential and business has been issued notices.

7 interviews have been carried out in relation to fly-tipping.

Barkby Road off St Ives Road - we have now concluded the large amount of waste, and all the owners complied with the legal requirements.

A number of City Wardens have also been assisting with cases in the ward and this has been a team effort to keep North Evington moving forward.
