# 1. Summary

The Local Nature Recovery Strategy (LNRS) is an umbrella strategy that will act as a framework for long term nature recovery across the country. The LNRS will address the need to protect nature and allow it to recover by preserving and improving habitats and biodiversity.

The strategy and supporting documents have been prepared by the County Council, as the Responsible Authority, with the districts and Rutland as supporting authorities.

The County Council will seek final approval of the LNRS at its Full Council meeting on 2<sup>nd</sup> July 2025, and thereafter request the right to publish from the Secretary of State.

# 3. Scrutiny / stakeholder engagement

Executive Members have been briefed throughout the process and the County Council, as lead authority, has undertaken extensive public and councillor consultation which has informed the development of the strategy.

The draft LNRS strategy was subject to extensive stakeholder and public consultation in January and February 2025. The results from the consultation process were then used to develop this strategy.

# 4. Background and options with supporting evidence

The LNRS for Leicestershire, Leicester and Rutland has been provided to the council by the County Council, as Responsible Authority, under regulation 7 of the Environment (Local Nature Recovery Strategies) (Procedure) Regulations 2023.

Leicestershire County Council was appointed as the responsible authority to lead on the strategy, working closely with the other local authorities, key stakeholders in land management, and supporting Department for Environment, Food and Rural Affairs (Defra) organisations.

The strategy and supporting documents have been prepared by the County Council, as the Responsible Authority with the districts and Rutland as supporting authorities. City council officers have been fully involved in the development of the strategy.

# 5.1 Financial implications

# 5.2 Legal implications

The Environmental Act 2021 establishes two mechanisms to support the delivery of LNRSs: mandatory Biodiversity Net Gain (BNG) and Section 106 (5) of the Environmental Act 2021 which requires the Councils to establish a LNRS to identify where action to achieve BNG will have the most impact and to encourage action locally through the way net gain is calculated. Councils are required to have regard to LNRSs in complying with strengthening their biodiversity duty.

The LNRS will act as a framework for long term nature recovery across the country. The LNRS will address the need to protect nature and allow it to recover by preserving and improving habitats and biodiversity. It is a guide for nature recovery across Leicestershire, Leicester and Rutland. It does not provide any new protection, designation or restrictions on how land can be used or managed or any other kind of legal designation. LNRSs provide data to inform opportunities for nature's recovery.

Development being promoted in areas of nature recovery will benefit from an enhanced BNG Metric with a 15% uplift which will make these areas more attractive to developing BNG habitat banks as well as allowing for higher scoring on site BNG investment, albeit offset by an equivalent uplift in the assessment of existing baseline habitat value.
