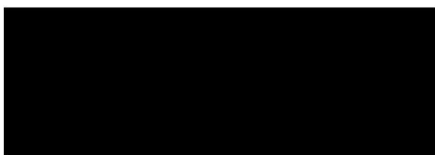

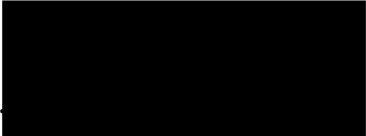

Please summarise your concerns about this application:
I refer to the above variation premises application for Emvee Lounge C/O Latimer Ward Conservative Inst.LTD on Surrey Street. The application includes extending the opening hours for late night refreshment and showing sporting events. Hours Requested Opening hours Sunday to Thurs 11:00-01:30 Friday and Saturday 11:00-02:30 Recorded Music Sunday to Thursday 11:00-01:00 Friday and Saturday 11:00-02:00 (indoors) Live Music Sunday to Thursday 11:00-01:00 Friday and Saturday 11:00-02:00 (indoors)

Please give further details of why you believe this application will have an adverse effect on the licensing objectives

My main concern is the effect on unregulated amplified music that could have a detrimental effect on the residents who are close proximity of the premises. If left unregulated it could lead to a statutory nuisance being witnessed. Previously we have seized and called a review of the club licence at this premises location.

I believe that the installation of a noise limiting device and agreeing a noise limit with the noise pollution team will prevent public nuisance.

The following conditions are recommended to be added to the licence:

- Installation of a noise limiting device and the level to be set and agreed by the Noise and Pollution team
- Receiving of deliveries must only be conducted between 07:00hrs and 22:00hrs.
- Emptying, dispensing or disposing of bottles in outside bins must only be conducted between 07:00hrs and 22:00hrs.
- Keeping all external door shut except for access and egress, in all the rooms involving amplified music or speech are taking place

I have discussed my concerns with the agent and an agreement document has been drafted and sent to the applicant.
