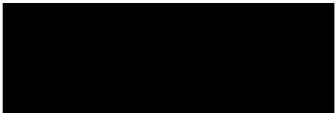
I am entirely confident in his ability to manage the proposed licence variation, as he actively meets and upholds the four licensing objectives in the following ways:
