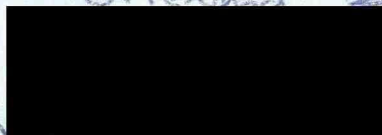

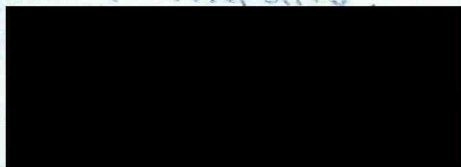

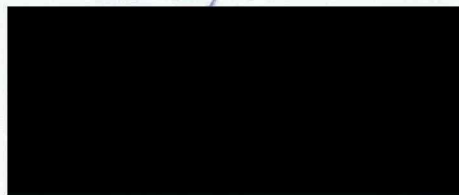

I am writing on behalf of Multiple nearby residents to request urgent review of the premises licence of Envy Lounge. Surrey St - Leicester LE4 6FG.

Current operation seriously undermines the Licensing objective specifically prevention of public nuisance.

① Breach of agreed hours music and noise continue until 1am - 2am 5-6 days a week.

2 Severe ongoing noise loud amplified music bass and exit noise keep resident awake affects sleep health, work and children's rest

③ No improvement despite complaints this has continued for months, no effective soundproofing

④ Cumulative harm consistent late night in a residential area causes persistent statutory nuisance.
