Please summarise your concerns about this application:

The area is a mixed use of mainly residential and various retail and food outlets.

There are existing residential properties adjoining this vacant ground floor unit and more residential properties in the immediate area.

The proposed hours for the playing of amplified music are:

Sunday-Thursday 1000-0000Hrs.

Friday and Saturday 1000-0200 Hrs.

The application includes a proposal for the sale of alcohol to be consumed on the premises.

During the daytime, road traffic, commercial activity and on-street activity are the dominant noise sources in the locality. However, later in the evening and into the early hours of the morning traffic noise and street noise noticeably reduces.

I am concerned that allowing the premises to operate such long hours will increase the likelihood of noise complaints and cause disturbance to residents by customers visiting the premises throughout the night and particularly into the early hours of the morning. There is also the likelihood of noise disturbance from deliveries and staff activities.

Noise on the street is very difficult to control and enforce. I am concerned that the premises staff will have little or no power to control customers once they have left the premises but may remain in the locality.

Noise from customer activity, noise from vehicles (doors slamming, stereo systems, revving engines etc.) when parked outside the premises or on the quieter local streets throughout the night would be difficult if not impossible for the applicant to control.

If the premises were to be granted a licence, the opening hours would potentially increase footfall to the area, this combined with delivery driver activity could result in noise nuisance to residents. I am concerned that the proposed opening hours of the premises will increase pedestrian and vehicular activity in the area thereby increasing the likelihood of noise complaints and cause disturbance to nearby residents.

I will attempt to contact the agent regarding my concerns and to discuss any possible noise limiting arrangements.

Please give further details of why you believe this application will have an adverse effect on the licensing objectives.

Occupants of adjoining and nearby residential properties could be adversely affected by noise from activity inside the premises, particularly when windows and doors are open.

Occupants of adjoining and nearby residential properties could be adversely affected by noise from patrons queuing/gathering outside the front of the premises on Uppingham Road, including after closing time.

I Anil Bhawsar acting for DOSTI Restaurant & Bar Ltd, the applicant for the above Premises Licence, hereby agree to the following conditions being added to any premises licence granted in response to the above application, in respect to prevention of public nuisance.

- The closing times of the premises to be: 2300 Hrs. Sunday-Thursday and 0000 Hrs. Friday and Saturday.
- The permitted hours for the playing of amplified music and/or voice indoors to be: 1000-2230 Hrs. Sunday-Thursday and 1000-2330 Hrs. Friday and Saturday.
- All external doors and windows shall be kept closed, other than for access and egress, in all rooms when events involving amplified music and/or voice indoors are taking place.
- Appropriate, clear signage requesting patrons and staff to keep noise to a minimum when outside and when leaving the premises, to be displayed in prominent locations.
- Disposal of waste bottles into external receptacles (where noise would be audible to occupants of nearby properties), shall not take place between 2100-0900 Hrs. Monday-Sunday.
