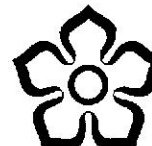

Your application for a premises licence has been processed and I am pleased to advise you that your licence has been granted. The licence is enclosed, together with a summary. Please make sure that you understand the terms of the licence and the conditions under which it has been granted.

Your attention is drawn to Section 57 of the Licensing Act 2003, which states;

"(2) The holder of the premises licence must secure that the licence or a certified copy of it is kept at the premises in the custody or under the control of

- a) the holder of the licence, or
- b) a person who works at the premises and whom the holder of the licence has nominated in writing...

(3) The holder of the premises licence must secure that

- a) the summary of the licence or a certified copy of that summary, and
 - b) a notice specifying the position held at the premises by any person nominated for the purposes of subsection (2),
- are displayed prominently at the premises."

It is an offence to fail to comply with the above requirements.

An annual fee is payable under the Licensing Act 2003, and this becomes due and payable each year on the anniversary of the date of the grant of the premises licence. Please note that this licence will not become effective until **24 November 2005**.

A questionnaire is enclosed, the results of which will enable us to monitor and improve the service we provide. I would be grateful if you could fill it in and return it to the Licensing Section at the address shown above.

Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule

The restrictions in this Annex do not prohibit any sale, supply or consumption of alcohol previously permitted by the Licensing Act 1964.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied.

Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- i) On weekdays, other than Christmas Day, 8 a.m. to 11 p.m.
- ii) On Sundays, other than Christmas Day, 10 a.m. to 10.30 p.m.
- iii) On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m.

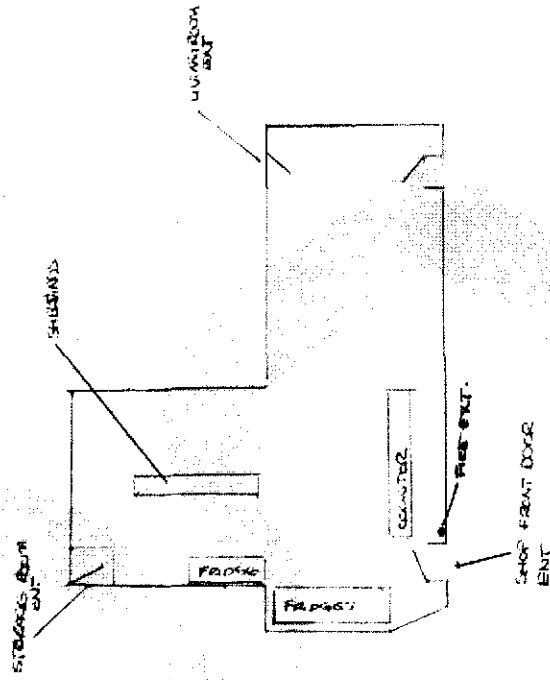
On Good Friday, 8 a.m. to 10.30 p.m.

Alcohol shall not be sold in an open container or be consumed in the licensed premises.

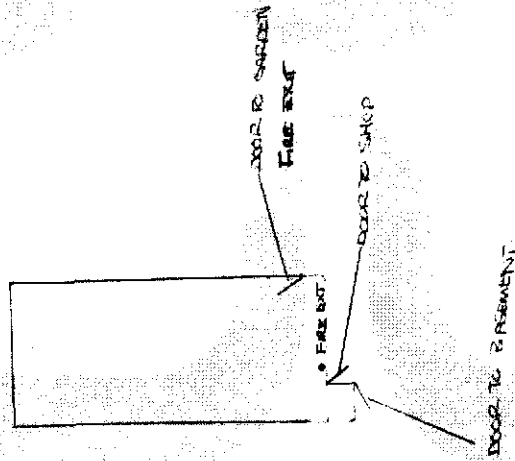
