#### 1.0 Introduction

## 1.1 Good Planning

Planning shapes the places where people live and work. Good planning ensures that the right development takes place, in the right location and at the right time. It helps towns and cities thrive and grow by providing jobs, homes and leisure opportunities whilst protecting and enhancing the historic environment and important open spaces. The Local Development Scheme, by setting out a timetable for the production of planning documents and guidance, helps achieve good planning by making sure the right policy framework is in place at the right time to influence the form of development in the city.

## 1.2 The Local Development Scheme

The Planning and Compulsory Purchase Act 2004 introduced a new plan making system at regional and local level, replacing the system of structure and local plans with Regional Spatial Strategies (RSS) and Local Development Frameworks (LDF). The Local Development Scheme (LDS) provides a public statement of the Council's current planning policies and sets out a programme for the preparation of a portfolio of Local Development Documents (LDDs) over the next three years until 2013. This is the third LDS that Leicester City Council have produced, and it replaces the March 2007 LDS which covered the period up to March 2010.

- 1.3 LDDs set out the spatial strategy for the City and comprise development plan documents (DPDs), which have development plan status and supplementary planning documents (SPDs), which are material considerations in determining planning applications. DPDs, together with the East Midlands Regional Plan (March 2009) comprise the statutory development plan, which is the basis upon which all planning decisions are made. DPDs have to conform to the RSS and they will progressively replace the 'saved' policies of the Adopted City of Leicester Local Plan 2006.
- 1.4 The Local Plan expired in January 2009, three years after its adoption, however a set of policies the Council intended to 'save' beyond 2009 was approved by the Secretary of State. These policies will continue to be relevant when deciding planning applications, until they are replaced by policies in adopted DPDs. The list of 'saved' policies can be found at Appendix 2.
- 1.5 A 25 year vision for the city has been set out in Leicester's Sustainable Community Strategy 'One Leicester: Shaping Britain's Sustainable City'. This


strategy has set the overall context of the LDF. Other Council Strategies are also taken into account, in particular the Housing and Cultural Strategies, and the Local Transport Plan.

- 1.6 Community and stakeholder engagement is a fundamental requirement of the planning system. The LDS includes consultation milestones to inform the public about how and when to get involved with the plan-making process.
- 1.7 The national and legislative regulatory framework for planning defines the process of production of the LDF. A number of changes have been made to that framework meaning that the process of production of LDDs has been simplified. These changes are reflected in this LDS.



## 2.0 Content of the Local Development Framework

- 2.1 In addition to the Local Development Scheme, the local Development Framework should also include the following documents:
  - Statement of Community Involvement (SCI) sets out the local authority's standards for involving key stakeholders and the local community during the preparation of all local development documents and in considering planning applications.
  - Development Plan Documents (DPDs) have development plan status and will be subject to formal consultation and independent examination. These normally comprise:
    - A Core Strategy a long term spatial vision for the City
    - Site specific allocations of land and Development Management policies
    - Area Action Plans (AAP) (where needed)
    - A Proposals Map
  - Supplementary Planning Documents (SPDs) elaborate on policy and proposals in DPDs and are material considerations in the determination of planning applications. They are not subject to independent examination, and do not have development plan status, but they must be subject to formal consultation with key stakeholders and the local community.
  - An Annual Monitoring Report (AMR) must be published to assess whether policies, targets and milestones have been met and it will inform the annual review of the Local Development Scheme (see paragraph 8.1).

#### 3.0 Local Development Documents

#### 3.1 Statement of Community Involvement

The SCI has been subject to public consultation and independent examination by a Planning Inspector. It was found to be sound and was adopted in September 2006. The SCI will be reviewed during the next three years. It should be noted that due to changes in the regulations, SCIs are no longer subject to independent examination.

#### 3.2 Proposed Development Plan Documents

The City Council has considered which local development documents it intends to prepare over the next three years. The schedule of proposed DPD's and programme chart provide information on timescales and consultation milestones.

#### Core Strategy

The Core Strategy will set out the vision, objectives and spatial strategy for the City. It must be in conformity with the East Midlands Regional Plan. It will also address the spatial aspects of the Community strategy, as well as other strategies and programmes of key stakeholders in the City. The Strategy was submitted to the Secretary of State in December 2009, with the document expected to be adopted in October 2010 following Public Examination.

#### • Site Allocations and Development Management Policies

The DPD will identify sites in the city needed to accommodate the range of land uses necessary to implement the objectives of the Core Strategy. It will also set out specific criteria against which planning applications for the development and use of land and buildings will be considered, along with details on developer contributions.

#### • Proposals Map

This will replace the Local Plan proposals map and will contain allocated sites and designated areas as set out in the DPDs. The map will be adopted alongside the Site Allocations DPD.

#### 3.3 Joint Waste Development Plan Documents

Leicester City Council and Leicestershire County Council are working together to deliver the joint Waste Development Framework. The Framework comprises of a Core Strategy, Detailed Development Control Policies, Site Specific Allocations and policies, and a Proposals Map. The Council adopted the Core Strategy and Development Control Policies DPD in October 2009.The Waste Site Allocations DPD was progressed alongside the Waste Core Strategy but held in abeyance following the preferred options stage to allow timely progression of the Core Strategy. It is anticipated that work on the Site Allocations DPD will recommence in the near future with the submission document timetabled for publication in January 2011.

3.4 The individual DPD profiles (Appendix 3) provide more details on timescales for preparation, the key stages for community involvement and management arrangements.

#### 3.5 Supplementary Planning Documents

The City Council will produce Supplementary Planning Documents (SPDs) as and when considered necessary to provide additional detailed guidance for Core Strategy policies. Information on existing and proposed SPDs can be found in the latest Annual Monitoring Report or the planning section of the Council website.

#### 4.0 Strategic Environmental Assessment /Sustainability Appraisal

4.1 Strategic Environmental Assessment (SEA) and Sustainability Appraisal (SA) are an integral process to the preparation of DPDs, and in some circumstances SPDs. The sustainability appraisal will inform the assessment and selection of options. This will require the appraisal of environmental, economic and social effects and implications of the spatial planning strategy and policies. Details of these assessments will be published for consultation along with the relevant local development documents.

#### 5.0 Background Evidence Base

- 5.1 To support the production of the Core Strategy a number of studies and surveys have been completed. This evidence base is important when testing the soundness of development plan documents and it is under constant review to ensure that the documents are based on accurate and up to date information.

- 5.2 The need for further up to date background information will be kept under review. Consultation with local communities and stakeholders will contribute towards the development of an evidence base that addresses social, environmental and economic issues and the long-term development needs of the City. A strong evidence base will help to ensure that future development plan documents are robust and able to withstand detailed scrutiny by an Inspector at the examination stage.

# 6.0 Project Management and Resources

- 6.1 The Planning Service will work as a team and in partnership to deliver the Local Development Framework. Primary responsibility for its production is with the Planning Policy team within the Planning Policy and Design Group. The Group also undertakes a range of strategic and local planning work, for example, input to the East Midlands Regional Plan, masterplanning, and policy input to planning applications.
- 6.2 The Urban Design team in the Planning Policy and Design Group are responsible for preparing most of the Council's design advice and site specific SPD. The Planning Management and Delivery, and Transport Strategy Groups, along with Prospect Leicestershire will also provide an

important input to the LDF. Officers in the Council's Housing teams will also provide a specialist input into the preparation of specific local development documents.

6.3 Joint working is taking place with Leicestershire County Council on the preparation of the Waste Development Framework. Consultants may also be engaged on specific projects where there is a lack of expertise or capacity in house, or where an independent view is required.

#### 7.0 Risk Assessment

7.1 An assessment has been carried out to identify factors that could impact on the delivery of the work programme outlined in the LDS. Actions to manage these risks are also identified.

#### 8.0 Monitoring and Review

8.1 An annual monitoring report (AMR) is prepared to assess the extent to which policies and proposals are being implemented and whether planned development targets are being met. The AMR assists in reviewing the timetable and key milestones for preparing the documents set out in the Local Development Scheme. The AMR is based upon the period 1st April to 31st March and must be submitted to the Secretary of State no later than the end of December each year.

## 9.0 Availability of Documents

9.1 All LDF documents are available from the City Council's Planning Policy and Design Group and can also be viewed on the Council's website at <u>http://www.leicester.gov.uk/ldf</u>. This link also provides information about the adopted City of Leicester Local Plan.
