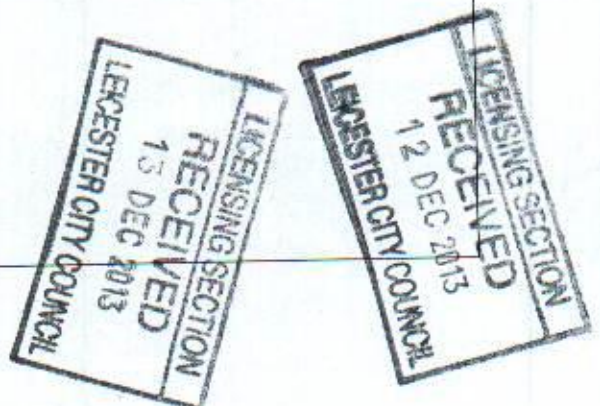

The application for a variation of the premises licence is to remove specified conditions, and to extend hours for licenced activities to 0400 on Saturday and Sunday nights, and to extend opening hours to 0430 on Saturday and Sunday nights. Any extension to hours on a Sunday night will be taking place at a time when Braunstone Gate is generally quiet, and consequently customers leaving Sumo on a Sunday night later than the existing closing time of 1.30am are likely to cause a disturbance to local residents.



Please give further details of why you believe this application will have an adverse effect on the licensing objectives

Customers leaving Sumo on a Sunday night later than the existing closing time of 1.30am, other than a Sunday night immediately before a Bank Holiday Monday are likely to cause a disturbance to local residents on a night before a working day.

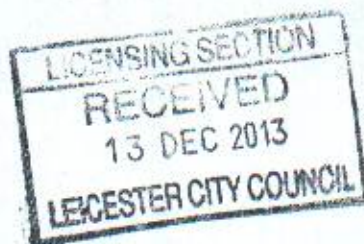

I, Manoj Kumar as the applicant of the above variation of a premises licence, hereby agree to the following modifications to the application in respect to prevention of public nuisance.

1. Licenced activities and opening times on a Sunday night shall continue to be as specified on the existing premises licence, namely 1100 to 0100 for licenced activities and 1100 to 0230 for opening times, other than Sundays before a Bank Holiday when licenced activities shall cease at 0400 and the premises shall close at 0400.
