ANNEXES

Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule

The restrictions in this Annex do not prohibit any sale, supply or consumption of alcohol previously permitted by the Licensing Act 1964.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal.

Licensable activities may continue between the end of the hours permitted by the licence on New Years Eve and the start of the hours permitted by the licence on New Years Day.

No person under fourteen shall be in the bar of the licensed premises during the hours that the premises is licensed for the sale of alcohol, except as previously permitted by the Licensing Act 1964.

The licence holder shall install and maintain a CCTV system.

The licence holder will adopt a zero tolerance policy on drugs, with signage to show this.

The licence holder will display signs detailing the emergency evacuation procedure.

The licence holder will ensure there is adequate lighting for all public access areas.

The licence holder will ensure that children are not allowed on the premises after 21.00.

The licence holder shall introduce a policy requiring the production of "proof of age" for any sale that takes place where there is any suspicion that the customer is under 18.

Annex 3 - Conditions attached after a hearing by the Licensing Authority

Outside area to close at 23.00 hours.

No minors to be allowed on the premises after 19.30 hours.

All external door and windows must be kept closed other than for access and in all rooms where music is played.

The challenged 21 policy will be employed at all times

A book will be kept to record any attempted under age purchases, which will be kept and produced on the request of the Police.

Any music will cease 30 minutes before licensable activities cease.

Signs will be displayed inside the premises requesting patrons leave quietly.

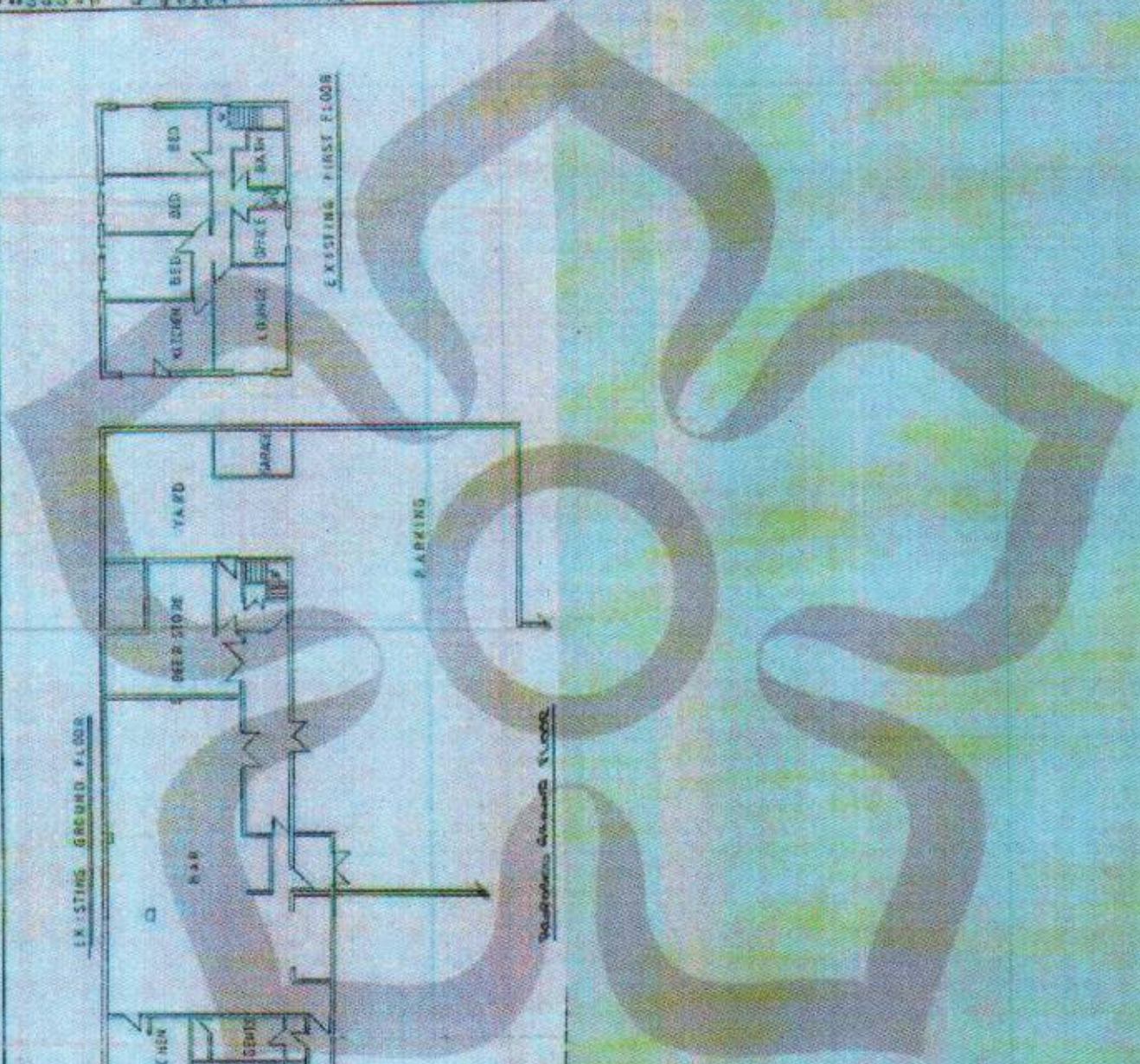
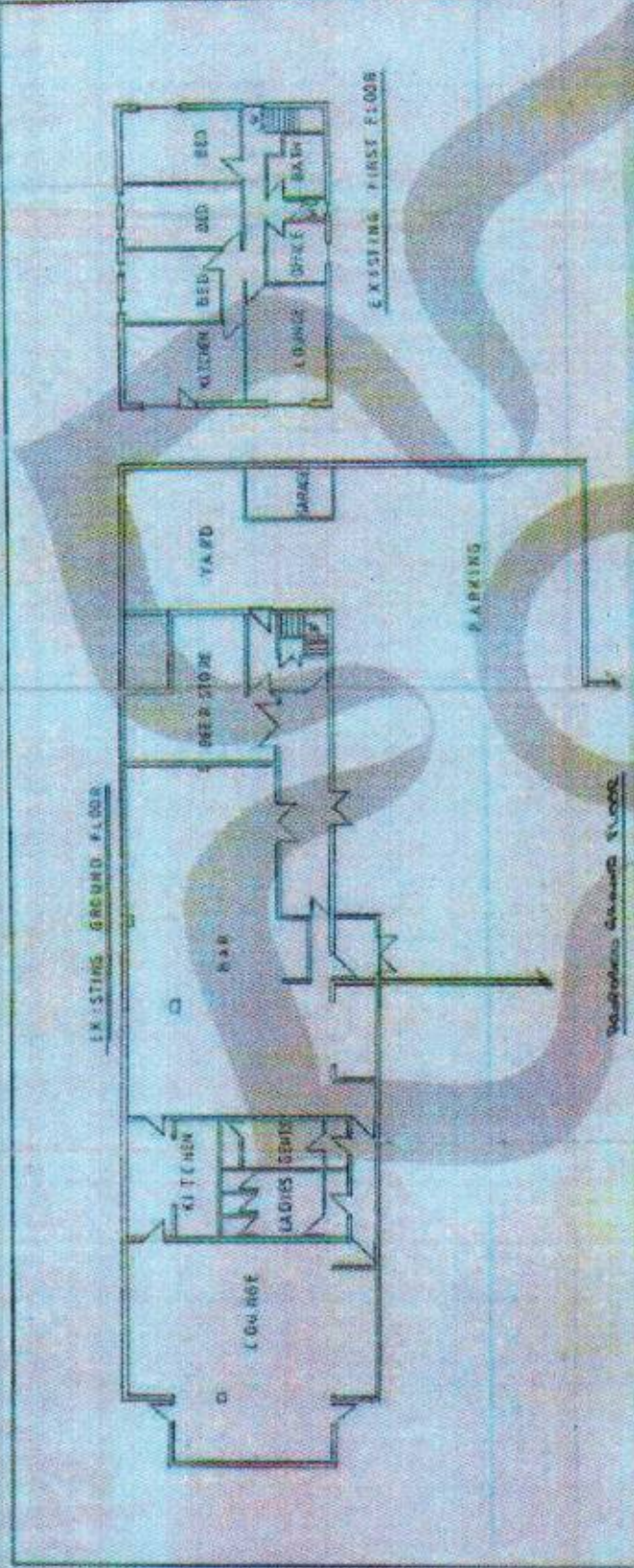


ANNEX 4 - PLAN
