#### **Report of the Director of Environmental Services**

#### 1. Purpose of Report

1.1. This report provides information for Members about an objection notice received in relation to a temporary event notice (TEN) given under the Licensing Act 2003, to assist them in determining the outcome.


#### 2. Determination to be made

- 2.1. Having considered the temporary event notice and the objection notice, Members must consider whether to
  - Give the premises user a counter notice under Section 105 (2) of the Licensing Act 2003 if it is considered appropriate for the promotion of a licensing objective to do so; or
  - Impose one or more conditions on the temporary event notice if:
    - o it is appropriate for the promotion of the licensing objectives to do so, and
    - the condition(s) are also imposed on a premises licence or club premises certificate that has effect in relation to all or part of the same premises as the temporary, and
    - the condition(s) would not be inconsistent with the carrying out of the licensable activities under the temporary event notice; or
  - Disregard the objection notice

#### 3. Summary

This report outlines an objection notice given by the Noise Team in response to a temporary event notice given by Mr Andrew Robert Moore for The Friary, 12 Hotel Street, Leicester LE1 5AW. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

#### 5. Temporary event notice

5.1. A temporary event notice was given on 20<sup>th</sup> May 2014 by Mr Andrew Robert Moore for an event at The Friary, 12 Hotel Street, Leicester LE1 5AW. The temporary event notice is for an event on the 14<sup>th</sup> June 2014 and is attached at Appendix A. Saturday 23.30 until 2am

5.2. The temporary event notice is for the following licensable activities:

Licensable activities	Proposed hours
The sale by retail of alcohol for consumption on and off the premises	Saturday 23.30 until 2am
Provision of regulated entertainment	Saturday 23.30 until 2am
Provision of late night refreshment	Saturday 23.30 until 2am

#### 6. Objection notice

6.1 An objection notice was received on 21<sup>st</sup> May 2014 from the Noise Team on the grounds of the prevention of public nuisance. A copy of the objection notice is attached at Appendix B.

#### 7. Existing premises licence

7.1 The premises identified in the temporary event notice is fully covered by an existing premises licence. One or more of the conditions on this premises licence may be applied to the temporary event notice if Members consider it appropriate for the promotion of the licensing objectives, and insofar as the conditions are not inconsistent with the carrying on of licensable activities under the notice. A copy of the existing premises licence, including the conditions are attached at Appendix C.

#### 8. Conditions

The Noise Team have indicated that they would be happy for the event to proceed subject to conditions from the premises licence being imposed on the temporary event notice. At the time of writing the report, the premises user has not agreed to this suggestion.

### 9. Statutory Guidance

9.1 Any decision made by the Licensing Authority must be in accordance with the licensing objectives. In addition, the government has issued guidance under section 182 of the Licensing Act 2003. The relevant parts of the guidance in this case are as follows:
