Costs have been obtained to separate the supply which will cost £8,000. The main route through the park is well lit and provides a good route for school children to get across the site. There is no identified need to provide additional lighting along the route between the school access path and Melton Road. School children who want to get to the Melton Road will exit the school on Melton Road and will not need to enter the park. To install the additional light columns along this route would cost around £9,000 and then have an ongoing cost of maintenance and energy use. There is no available budget for this. This route forms part of a larger ecologically sensitive area and current advice is to avoid installing lighting which would affect areas of this type.
