1. Purpose of Report

1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.

2. Determination to be made


- 2.1. Having considered the application and representation, Members must consider whether to
 - Grant the licence without modification
 - Grant the licence subject to conditions
 - Refuse to accept the proposed premises supervisor
 - Reject the application

3. Summary

3.1 This report outlines an application for a new premises licence for Mini Karczma, 80 Narborough Road, Leicester within the Braunstone Gate area Cumulative Impact Zone and summarises the representation received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

5. Application

- 5.1 An application was received on 13th June 2018 from Ms Magda Zelazek for a new premises licence for Mini Karczma within the Braunstone Gate area Cumulative Impact Zone. A copy of the application is attached at Appendix A.
- 5.2 The hours sought by the application are as follows:

Licensable activity	Proposed Hours
Supply of Alcohol (on)	Monday to Sunday 12 noon to 9pm
Opening hours	Monday to Sunday 12 noon to 9pm

6. Steps to Promote the Licensing Objectives

- 6.1 The steps the applicant proposes to take to demonstrate that the premises will not add to the existing cumulative impact and promote the licensing objectives are set out in the operating schedule (see section M of Appendix A).
- 6.2 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

7. Representation

7.1 A relevant representation was received on 9 July 2018 from Leicestershire Police. The representation relates to the prevention of crime and disorder, the prevention of public nuisance, public safety and the protection of children from harm. Leicestershire Police are concerned that the applicant has made no reference to the cumulative impact zone in her application to show the premises will not add to existing problems in the area. They also comment that the promotion of the licensing objectives has not been considered on the application. They have specified conditions they would like added to the licence if granted. A copy of the representation is attached at Appendix B.

8. Conditions

8.1 The conditions that are consistent with the operating schedule are attached at Appendix C.

9. Cumulative Impact

9.1 In February 2011 Leicester City Council introduced a special policy on cumulative impact in the Braunstone Gate area, which refers specifically to on and off licences. This creates a rebuttable presumption that an application for a new premises licence will be refused, unless the applicants can show that their premises are unlikely to add to the problems of saturation.

10. Statutory Guidance
