1. Purpose of Report

1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.


2. Determination to be made

- 2.1. Having considered the application and representations, Members must consider whether to
 - Grant the licence without modification
 - Grant the licence subject to conditions
 - Exclude from the licence any of the licensable activities
 - Refuse to accept the proposed premises supervisor
 - Reject the application

3. Summary

3.1 This report outlines an application for a new premises licence for Polskie Delicje and summarises the representations received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

5. Application

- 5.1 An application was received on 2nd October 2018 from Polskie Delicje Ltd for a new premises licence for 235 239 Hinckley Road, Leicester. A copy of the application is attached at Appendix A.
- 5.2 The application is as follows:

6. Steps to Promote the Licensing Objectives

6.1 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section M of Appendix A).

6.2 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

7. Representation

7.1 Two representations were received on 30th October 2018 from local residents. The representations relate to the prevention of crime and disorder, the prevention of public nuisance, public safety and the protection of children from harm. The residents are concerned that there are already issues in the area with crime and disorder, littering and groups of people drinking in the street. Copies of the representations are attached at Appendix B.

8. Conditions

8.1 The conditions that are consistent with the operating schedule are attached at Appendix C.
